

This large format, soft cover book gives detailed information on 50 divable wrecks located between the Mexican border and the Point Conception area which is north of Santa Barbara. It also includes wrecks, around the Channel Islands. I have asked Pat to bring along several copies of the book. The price is \$12.95 for anyone interested in purchasing one.

Pat has been a certified diver since about 1961 and is also a NAUI instructor. This is his first book, however, he has had several articles in publications such as "California Diver", "Skin Diver Magazine", "Underwater USA", and "International Divers Guide".

In his presentation to us on April 3, he will discuss several wrecks but will be sure to include information on both the Olympic and the Avalon since the club's April dive trip features these wrecks. Be sure to join us at Pancho and Wong's for this exciting presentation.





Season: Open during April thru June and August thru November, No SCUBA allowed when hunting abs.


Limit: 4 in any combination of species.

### (INCLUDES FOOD, AIR AND PARTY!)

Seems like only yesterday we were on the PEACE for our September two-day — but here it is approaching May, some eight months later, and another great two-day to SAN MIGUEL and SANTA ROSA.

We will leave Ventura Marina in the early AM on Friday the 18th, and cruise over night to the east end of SANTA ROSA Island where we'll begin diving for the day. We will work along either the north side of the island or the south side depending on weather and ocean conditions, making five or six dives for the day. The pinnacles and reefs around SANTA ROSA provide a habitat for large RED ABALONE, SCALLOPS, FISH and superior spots for PHOTOGRAPH and/or VIDEO. An early evening twilight dive may be featured at or near our overnight anchorage.

Once anchored for the night, we will partake of dinner PEACE-style. Dinner will include several varieties of wine for those wishing to partake. Socializing, story telling, and general hot tub activities are the order of the day and usually provide for a very pleasant evening.

The second day—Saturday, the 19th—will be spent around SAN MIGUEL and again, depending on weather and ocean conditions, we will dive LITTLE WILSON, WILSON ROCK or RICHARDSON'S ROCK. We anticipate three or four dives on the second day before our cruise back to Ventura. Game in the SAN MIGUEL environs is more plentiful than on any of the other Channel Islands.

Typical diving on our two-day trips is suitable for all levels of experience, however, dives at WILSON or RICHARDSON'S ROCK are advanced dives in all but perfect weather/ocean conditions. Dive masters should be consulted before making potentially difficult dives — know your own personal limits.

If you just want to dive a little and/or cruise a lot, there is no better boat or trip than this! We will add to the charter with other goodies, including prizes for boobie, sign-in and hero; fun and socializing. As you all know, the PEACE is an extremely popular boat and as of this writing (mid-March) the boat is already full with a wait list. ## "OLYMPIC" AND "AVALON" WRECKS AND PALOS VERDES (INCLUDES FOOD AND AIR)

CHARISMA

**NON-MEMBERS \$62** 

This charter is one of our once a year opportunities to sample and or/experience something different. On our second trip in 1990 with the mighty CHARISMA out of 22nd Street. We will be diving on the fascinating wrecks of the "OLYMPIC" and "AVALON" followed by two or three shallower dives on some of the excellent reefs around the PALOS VERDES PENINSULA. In addition, for those divers not used to deep diving, there will be a mini-seminar on board on wreck and deep diving, plus the grouping of less experienced divers with advanced divers, dive masters or instructors. As part of the day's activities, each diver will be provided with an eight to ten page handout describing in detail the history, sinking, present condition (with sketches) and general diving tips on both wrecks and a summary of diving around he PALOS VERDES coastline. We will also have a couple of prizes on board for the "hero" and "boobie" of the day!

We will leave the dock at 7:00 AM sharp and head on out to the "OLYMPIC" some 3-1/2 miles out from L.A. Harbor. The "OLYMPIC" was built in Belfast, Ireland, and launched in 1877 as the STAR OF FRANCE. She was an iron hulled, square-rigged bark of 1,644 tons, 258 feet long and 38 feet wide. Some 63 years later she was rammed amid ships by the "SAKITO MARU" about 7:00 AM on 4 September 1940, and sank within minutes with 17 of 24 on board surviving. The "OLYMPIC" lies essentially on the, starboard side in about 100 feet of water. The highest part of the bow is about 70 feet below the surface with the bowsprit extending out over the sandy bottom. The midship section is approximately parallel to the sand and is in relatively poor shape, however, mast stubs are visible, as is the deck pump and its large spoked wheels. Also, if you spend a little time on the port side, you can still see the remains of the huge V, cut by the "SAKITO MARU" The top of the stern is about 80 feet below the surface and this section is between 40 and 50 feet long. The whole wreck is covered with strawberry anemones. It is a fascinating dive.

We will then head off towards PALOS VERDES POINT and the wreck of the "AVALON" some 15 miles from the "OLYMPIC". The "AVALON" was built in Cleveland, Ohio. and launched in 1891 as the "S.S. VIRGINIA." She was a steel hulled, triple deck, twin screw passenger steam ship of 1,985 tons, 265 feet long, and 38 feet wide. Some 69 years later, while being used in salvage attempts of the "S.S. DOMINATOR", she sank during the night of 18 July 1960, after breaking away from her moorings in a violent storm. There was no loss of life. The "AVALON" rests in about 70 feet of water, between and parallel to the rocky ridges, with the major wreck sections partially on their port side. The relatively intact bow section is some 90 feet from the rest of the wreck, which begins with a debris field that includes steel deck plates and hull ribs. The debris field slowly rises and is connected to the very recognizable stern section. There is a small cabin and the deck crane (complete with tracks) and its separated derrick off the port side of the stern section. Some sections of the wreck are covered with a variety of sea life.

Wreck diving over, we will begin to work our way around the PALOS VERDES PENINSULA towards San Pedro, picking two or three of the best reefs for some relatively shallow diving. Surprisingly to some, marine life flourishes in the area with excellent prospects for spearing several popular and good size varieties of FISH, including calico bass, VIDEO and PHOTO enthusiasts will not be at all disappointed with the underwater opportunities in the coves, on the reefs and in the kelp forests. We anticipate a very interesting day out with an unusual selection of dives, that should provide for more than the average charter. refurbished as a Manila Galleon, stolen by Spain and refitted as a Spanish Frigate, bought by American businessmen to be put on display in Europe and confiscated by Hitler at the beginning of World War II: the Ning Fred. Only a handful of people knew of the Ning Fred and that it sank near the end of World War II with a shipment of gold that was to secretly purchase Australian Army hats for German soldiers to boost their sagging morale. I had spent all of my spare time in the last ten years researching the ship and had narrowed the wreck location to one of two geographic specifics: Either Egypt or Tasmania.

I arrived in the tiny village of Pocoima, Tasmania, just as the sun declined below the sultry, jungle covered peaks. I needed a drink. It was difficult to relax in the humidity, especially since I knew I had enemies. Word had gotten out about my search and there was little doubt rival wreck divers were tailing me.

I slipped into the sleazy little bar as inconspicuously as possible. The air was thick with cigar smoke and filled with the stench of unbathed and overworked peons. Wreck divers! I thought to myself.

The room was hotter than a Mexican Jail cell. I slowly walked toward an empty table. Dropping my duffel bag on the floor, I reclined in the rickety cane chair and began to scan the perimeter of the bar for the familiar face of a rival treasure hunter. It was difficult to concentrate as off key piano notes seemed to suspend themselves in the dense air. I sought the direction from which the music radiated. In the corner, an antiquated upright piano seemed to dwarf a small Asian man who haphazardly punched at the keys in a pathetic attempt to play As the time goes by.

I continued scanning the bar room past the piano player Through the smoky haze appeared a familiar face. She sat on a barstool as sultry and seductive as ever — Thelma Bartholomoski, and Ex-Soviet spy who defected to the United States to become a wreck diver

#### **DIVE BOAT POLICY**

- A club member may, but is not required to, have a boat deposit on file with the club.
  - A club member will have a confirmed reservation on an upcoming dive only if:
  - A check in the full amount for the dive has been received by the dive boat reservationist, or

    The club member has a deposit on file with the club and makes a telephone request for a reservation with the dive boat reservationist.
  - For TWO DAY DIVES, a minimum of one half of the price of the dive must be recieved by the dive boat reservationist. Dive Boat deposits may be used as a part of the one half requirement.
- Any reservation may be cancelled two weeks prior to a dive with a full refund. Cancellations will not be accepted within two weeks prior to the dive unless a diver holding a reservation can sell or transfer their reservation to another qualified diver. The dive reservationist will assist in this process, but is not responsible to provide paying alternates. When confirmation is received by the dive boat reservationist that a cancelling diver is being replaced by another qualified diver, the replacement diver is then fully responsible for the cost of the dive
- 4) If a diver has a deposit on file with the club and uses that deposit to secure a reservation on a boat dive, he may not use that deposit to secure any additional dives until he has paid the club for the first dive. Two years after a diver has ceased to be a member of the club, his unclaimed dive boat deposit will be forfeited to the club.
- Only Sea Diver club members and members of other selected clubs may make boat dive reservations prior to one month before a scheduled boat dive Partial refunds from boats which do not make the advertised dive location will be passed on to members who request them within two weeks of the dive
