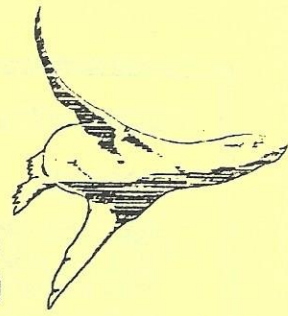




# THE SEA DIVERS

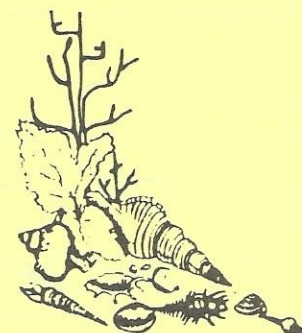
Aside from LOBSTER, SANTA BARBARA offers just about every element for diving. The multiplicity of reefs, walls, arches and canyons provide superior opportunities for PHOTOGRAPHY and VIDEO. Add to that the extensive variety of sea life and typically great visibility and you've got the best of diving. Some of the larger FISH inhabit the environs --- so you spear hungry types will not be disappointed. Also, this is the ONLY dive this year when LOBSTER and ABALONE are both in season --- can't go wrong!?

Ocean conditions can vary tremendously around this relatively small island -- inexperienced divers should consult with The Sea Diver divemaster before committing to a specific dive. Call Scott (Williams) at (213) 371-9985 for signup. As usual, boarding will begin around 8:00 PM on the 9th. We plan something special for apres-diving on this trip. BE THERE! BUGS AND ABS!!!

### A DIVE WITH ALMOST EVERYTHING!

13 APRIL 1991 (Saturday)

"OLYMPIC" WRECK/CATALINA

CHARISMA

MEMBERS \$63

WRECK, ABALONE, SCALLOPS, FISH and great opportunities for PHOTOGRAPHY or VIDEO are all features of this somewhat different dive on the CHARISMA out of 22nd Street. This single day affair will leave the dock at 7:00 AM prompt and be over the wreck of the "OLYMPIC" ready for diving by 8:00 AM -- a nice leisurely start to the day!

The "OLYMPIC" is a deep (90-100 feet) dive, but is one of the more spectacular wrecks in the area. The "OLYMPIC" was built in Belfast, Ireland, and launched in 1877 as the "STAR OF FRANCE." She was an iron hulled, square-rigged bark of 1,644 tons, 258 feet long and 38 feet wide. Some 63 years later she was rammed amidstships by the "SAKITO MARU" around 7:00 AM on 4 September 1940, and sank within minutes with 17 of 24 on board surviving. The "OLYMPIC" lies essentially on the starboard side in about 100 feet of water. The highest part of the bow is about 70 feet below the surface with the bowsprit extending out over the sandy bottom. The midship section is approximately parallel to the sand and is in relatively poor shape; however, mast stubs are visible, as is the deck pump and its large spoked wheels. Also, if you spend a little time on the port side, you can still see the remains of the huge V cut by the "SAKITO MARU." The top of the stern is about 80 feet below the surface and this section is between 40 and 50 feet long. The whole wreck is covered with strawberry anemones. It is a fascinating dive.

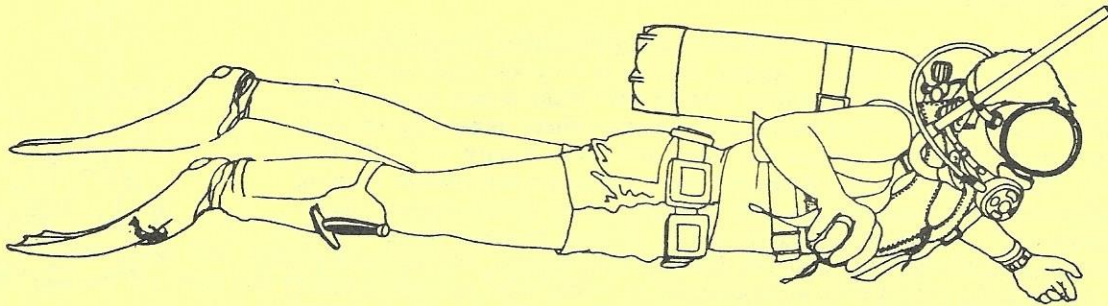
Following the "OLYMPIC" dive, we will cruise over to the frontside of CATALINA, partaking of full breakfast on the way over. We will head towards the Isthmus area and then work our way back along the coast towards Avalon making at least three and maybe four shallower dives. ABALONE, typically pinks and greens, can be found in these shallower waters of sometimes steep and rocky areas. Most of the pinnacles and reefs contain SCALLOPS and great opportunities for PHOTO and VIDEO buffs. Spear hunting of the local FISH can also be rewarding, especially Calico Bass, which are a challenge to any self-respecting diver!!

You can't want for much more than this trip offers. An almost everything dive on board the mighty "CHARISMA." The trip will provide diving for all skill levels. Call Scott (Williams) at (213) 371-9985 for sign-up -- should be a great series of dives with added Sea Diver goodies besides!

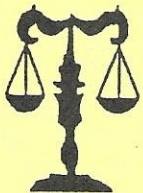

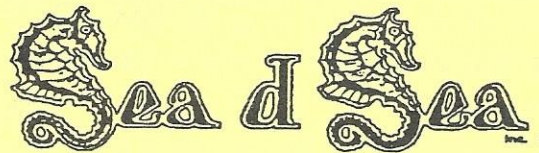

## THE THREE AND THREE-SIXTEENTHS TRIP

We finally hit a planned charter where the weather forecast sounded good. Our 12 January trip on CHARISMA to San Clemente was to be in warming weather with a mostly sunny day and calm ocean conditions.

After a last minute flurry of cancellations and wait list activities, we left 22nd Street with a full boat, but minus divemasters. The channel between San Pedro and Catalina was calm, but once we cleared the east end of Catalina, residual swells made for a somewhat bumpy but not uncomfortable ride. Much to our surprise, daybreak showed we were indeed on the backside of San Clemente, and skipper John finally anchored near Eel Point about halfway along the backside, just in time to be buzzed by a U.S. Navy F-14 Tomcat -- impressive!

The first dive was in about 60-70 feet of calm, clear 56 degree F water with visibility in the 50 foot range. Lots of rocks and reefs were perfect for lobster and pink abalone (out of season!!!!). Most of our divers got to play with the lobster but most commented that nearly all were "just short," "a ---- hair short," "barely non-legal," etc., etc. The second and third dives were just west of the Eel Point rocks and just east of the rocks respectively with slightly shallower water, and surprisingly different topography -- including large open caves on the third dive. Exactly the same results on lobster! Water temperature was in the mid-fifties, again with great visibility. The final dive was the most westerly spot from the point, and although the boat was anchored in 30-40 feet, it was possible within the reef structure to make 70 feet depth easily -- see the lessons learned article elsewhere!! The water was also somewhat surgy.

Diving over, we began the long run back to 22nd Street, stopping and circling for a while off the west end of San Clemente to view a couple of large grey whales migrating south. We also awarded a booby prize (a \$25 certificate) to Ken S for performing minor surgery on his stomach as a result of diving with a pair of scissors between his farmer john and his body -- another few inches and it could have been a very personal issue!! Others in the running were Bob S and John D -- they're always in the running -- Rose S and myself -- again see lessons learned elsewhere!!

We arrived back at 22nd Street at about 7:00 PM. The weather was fine, but the sun never did quite stay "on" due to the low level clouds and mist --- most of the discussion on the way back was to how on earth nearly all lobster measured 3-3/16". John D surmized that that was the maximum they grow to and that anything over that was a mutant form of crustacean!!

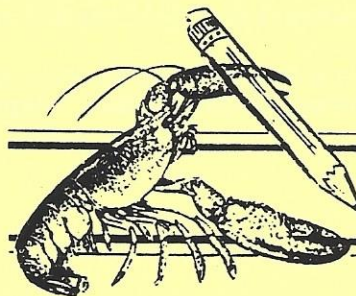

## LESSONS LEARNED

I have been diving with a U.S. Diver Data Scan II computer for about two years, and although it has been superseded by the Data Scan Sport which uses a less conservative algorithm, I have chosen not to update it as I like the in-built conservatism -- it's my body!

On the "Charisma" single day dive to San Clemente, my dive profile for the first three (of four) dives was as follows:

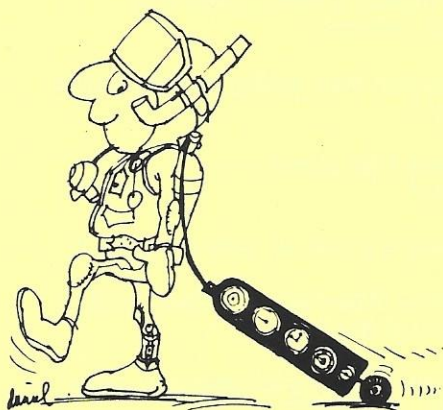
Dive 1	75 feet for 32 minutes
Dive 2	53 feet for 36 minutes after 67 minutes of surface time
Dive 3	58 feet for 28 minutes after 56 minutes of surface time

The fourth dive was in an area where the reef structure was very varied with depths from 25 to 75 feet. There was a fair amount of surge, especially in the mini-canyons, with the surge carrying the diver back and forth, as well as up and down. As I entered the water, my trusty computer indicated a surface time of 56 minutes and the scrolling showed that my bottom time became decompression limited below 50 feet (rather than air consumption limited). At about 13-14 minutes into the dive, most of which to this time was at 30-35 feet, I began to drift deeper and at one point "rode the surge" down a mini-canyon and out into an open area with a vertical but short wall. At the bottom of the wall was an area strewn with square boulders -- ideal for lobster, and I'm due! I swung down and began to poke around. After a couple of minutes, I checked my computer and surprise, surprise, I am one minute PAST no-decompression time and as I'm staring at the readout, it immediately goes to minus two minutes. I am at 68 feet at 16 minutes plus into the dive. I signalled to my buddy (Kathleen B), who is 10-15 feet above me, and began to rise. By the time I reached 20 feet, I'm 4 minutes beyond no-decompression, and as I "hang off" on the kelp, up comes 5 minutes. Now I KNOW my computer is conservative and Kathleen's Skinny Dipper is not unhappy with her very similar, although different dive profile (she made the third dive with Ken S). Nevertheless, I decided to go through the appropriate decompression steps and after a stop at 20 feet, another at 10 feet, and a short swim back to the boat (also at 10 feet), I reached the step with 2 minutes to the plus side (i.e., "good") of no-decompression.

The lesson is obvious, and has been repeated many times. No matter whether you dive Navy tables, the Wheel, computers (conservative, not so conservative, and downright liberal), one must always be aware of depth changes, especially in a multiple dive profile situation. In this particular set of circumstances, it was also possible to go deeper on the last dive, it was cold and our surface intervals were relatively short. It is also worth noting that if I had been using the Navy dive tables, I exceeded those dive profile limits by 20 minutes on the second dive!

If you find yourself in a decompression situation, AND YOU SHOULDN'T, then perform the proper decompression stops, air supply allowing. Better safe than "winging it;" sometimes it's only taken one screw-up for a major injury or worse.

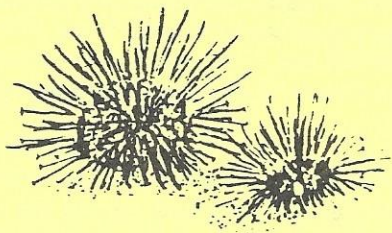

## THE SEA DIVERS 1991 DIVE BOAT BONUS PROGRAM

The program is open only to club members.

Base period will be 1 January 1991 through 30 November 1991.

Members must have supported a minimum of four dive days (i.e., four single-day dives or one two-day and two single-day dives, or two two-day dives). There are sixteen dive days scheduled in the base period.

For divemasters all days count, dollar amounts will count to the extent received by the club.

The bonus can only be used on the Peace two-day scheduled for 13/14 December 1991. The bonus amount will be refunded to each qualified diver on the dive.

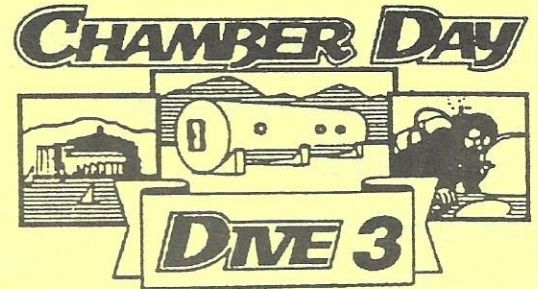

### "WILD WAVE" TO SAN NICOLAS

Once again Mr. Weather cooperated for our trip on the "Wild Wave" to San Nicolas Island. Friday, 1 February, was warm and clear and the ocean was apparently almost flat. Saturday was to be warm also, with high clouds passing through.

We left the dock a few minutes past midnight and as we rounded the L.A. Light, unanticipated bumps and bangs set in . . . so much for flat! However, as we left the mainland behind the ride got smoother and smoother and by the time we reached the west end of San Nicolas, at about 6:15 AM, the ocean was almost as flat as anticipated. We waited for first light before anchoring in 80-110 feet of fantastically clear water -- divers could see the boat from 100 feet below!! Water temperature was still about 55 degrees F which should be (hopefully) the low for this winter. The bottom was flat with "canyons" criss-crossing the area. Several bugs were snagged, including one around 5-3/4 pounds (by Kathy D). We moved a whole 100-200 yards for our second dive; conditions obviously being very similar. Those divers without computers were already "on the table" and had to sit this one out -- the hardcore computerites went for it, most making safety stops on the way up, just to be sure. Again, a couple of nice bugs were brought on board.

Deep diving over . . . no kidding . . . we headed for the shore, ignoring the Navy 300 yard edict and anchored about 50 yards off in about 25 feet of water. Visibility dropped to about 30 feet, but was still excellent. Some bugs were found real shallow -- like standing up in the surf line!! Dick Mc fought the biggest bug he's "ever seen" in five feet -- the bug won!! Skipper Joel I went after the same bug -- zero for two!! By plan, I was a "panicked victim" for Jim M as part of our divemaster training program. I probably won't get an Oscar for the act -- but it is an easy way to get back to the boat!


For our last dive we moved about 500 yards down the coast, remaining in 20-30 feet of water. Visibility increased a little, but the bugs were "on vacation." We raised anchor and Joel I pointed the "Wild Wave" towards San Pedro at about 12:30 PM, crossing the path of the "Peace," which was heading back to Ventura.

Our run back was smooth and uneventful. We had our usual excellent steak lunch with all the goodies, including dessert, etc. -- the galley did a great job all day. We seriously considered a boobie prize, but finally decided to hold off as we didn't have a real spectacular candidate. Those in the running included: Dan S for sending a check for "the November dive;" Ken S (again) for jumping in without his fins (said it was to see if divemaster Jim M was watching !?); Kathy D for coming up too close to the boat to be Kathleen B's "unconscious victim" -- Kathy made up for it on a later dive by coming up way, way, away from the boat; and Pete K and John D (again) for repeatedly spilling beverages on the number two table and seats and people!!

The sun never really came out per forecast, but it was a great day of diving -- the water could not have been much better for this time of year. We docked at about 6:30 PM . . . another fast run from San Nicolas on the Express. By the way, we have been carrying on each dive a \$50 dive light as an unannounced prize for anyone bringing up an 8 pound bug --- last chance is March 10th!!!

### *Wild Wave/Charisma/Encore - 22nd Street Landing*

South on Harbor freeway, left on Gaffey, left on 22nd Street, down the hill and park in designated areas.

### *Peace - Ventura Marina*

North on Ventura freeway to Victoria Ave. in Ventura. Turn left onto Victoria and continue to Olivas Park Drive. Turn right and continue all the way down toward the beach and across Harbor Drive; go to the left on to Spinnaker Drive. Look for Milano's Italian Restaurant and turn right into the parking area. If you get to the end of Spinnaker, turn around and take the second left. Park adjacent to the berth (Slip #20) to unload, then park overnight in the last row adjacent to Spinnaker Drive.

### **DIVE BOAT POLICY**

A club member may, but is not required to, have a boat deposit on file with the club. A club member may make a reservation on an upcoming dive as follows:

- A) Unconfirmed reservations may be made for any boat dive at any time. To confirm a reservation, payment in full must be received.
- B) For single day dives, divers holding an unconfirmed reservation will be called 3 weeks prior to the dive and advised that payment in full is required no later than 15 days prior to the dive to be confirmed. Dive boat deposits will be considered as payment in full.
- C) For two day dives, divers holding unconfirmed reservations will be called 5 weeks prior to the dive and advised that payment in full is required no later than 30 days prior to the dive to be confirmed. Dive boat deposits may be used as part of the payment in full.
- D) If payment in full is not received by the deadline, the diver may be replaced by a wait listed diver who has paid in full.

Any reservation may be cancelled two weeks prior to a dive with a full refund. Cancellations will not be accepted within two weeks prior to the dive unless a diver holding a reservation can sell or transfer their reservation to another qualified diver. The dive reservationist will assist in this process, but is not responsible for providing paying alternates. When confirmation is received by the dive boat reservationist that a cancelling diver is being replaced by another qualified diver, the replacement diver is then fully responsible for the cost of the dive.

If a diver has a deposit on file with the club and uses that deposit to secure a reservation on a boat dive, he may not use that deposit to secure additional dives until he has paid the club for the first dive. Two years after a diver has ceased to be a member of the club, his unclaimed dive boat deposit will be forfeited to the club. Only Sea Diver club members and members of other selected clubs may make boat dive reservations prior to one month before a scheduled boat dive. Partial refunds from boats which do not make the advertised dive location will be passed on to members who request them within two weeks of the dive.

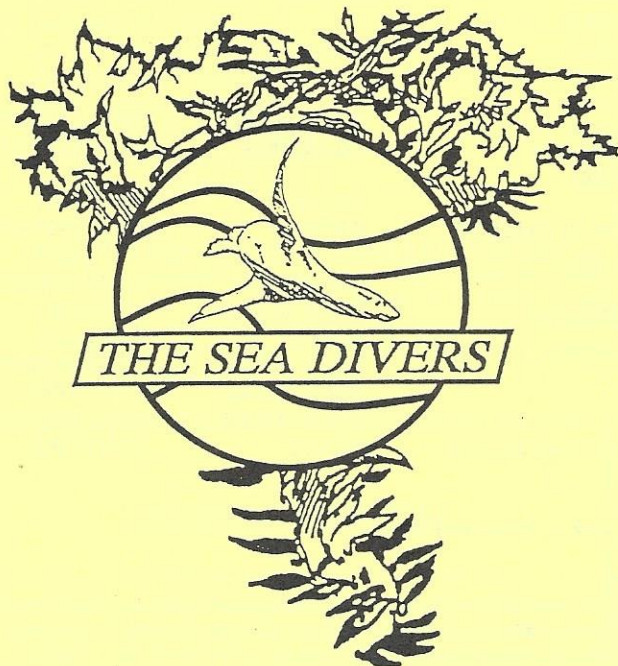
