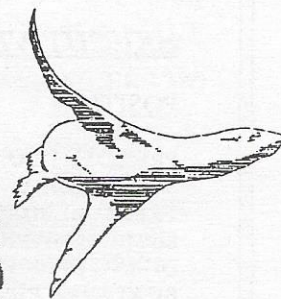

Peter was part of a research team collecting pre-juvenile fishes for a UCLA marine biology professor. Interestingly enough, the professor was not a diver, so Peter and one other diver, joined occasionally by the captain, collected the fish. Some of the collecting was done using a "super snorkel" which Peter brought with him. It uses 1 quart of gas and from a float towed along behind, it can supply air to two divers for about 3 hours. You probably won't want to hear that the water temperature was 80-83 degrees the whole time.

How does Peter always manage to take such exotic trips?!?! This is sure to be an interesting program. Hope to see you all on 1 October.

Although we have tried several times in the past year or two, we have not dived CORTEZ BANKS since a two-day affair in October of 1984. CORTEZ is a great LOBSTER area and with two days to work with, we hope to be successful this time!!!

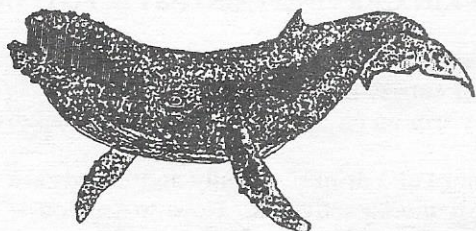
CORTEZ BANKS is located about 80 miles SSW of 22nd Street, about 40 miles SW of China Point on San Clemente Island and is almost directly west of San Diego. As it is an exposed dive spot, the BANKS have not been dived as much as some of the closer in areas. Diving depths range from 20 to 80 feet providing generally excellent game taking possibilities. LOBSTER in particular have been abundant and the various reefs making up the BANKS are home to many species of good sized FISH. PHOTO and VIDEO buffs will not be disappointed. Our "fallback" will be SAN CLEMENTE Island which also has great dive spots.

This dive is generally considered an intermediate to advanced dive due to the BANKS' full exposure to the ocean. However, relative beginners can make the dives, assuming that ocean conditions relative to surge and/or current are within acceptable limits. The Sea Diver divemasters should be consulted on your dive plan and/or experience.

This is a great dive area and as usual the charter is filling early. Call Kathi (McNally) or Allen (Parker) at (213) 370-1657 for further details or sign-up. Boarding will begin at 9:00 PM on the 31st of October for a prompt midnight departure from 22nd Street. As the run back will be fairly long, we plan some additional goodies for this trip.

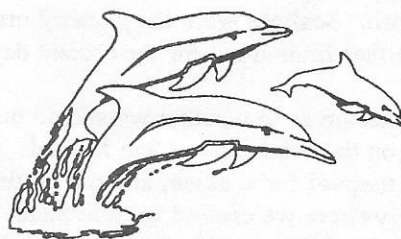

THE SEA DIVERS 1991 DIVE BOAT BONUS PROGRAM

- The program is open only to club members.
- Base period will be 1 January 1991 through 30 November 1991.
- Members must have supported a minimum of four dive days (i.e., four single-day dives or one two-day and two single-day dives, or two two-day dives). There are sixteen dive days scheduled in the base period.
- Free trips do not count, nor do club certificate dollars.
- For divemasters all days count, dollar amounts will count to the extent received by the club.
- The club will pay a 5% bonus on dollar amounts accrued by qualifying members.
- The bonus can only be used on the Peace two-day scheduled for 13/14 December 1991. The bonus amount will be refunded to each qualified diver on the dive.

A BEAUTY — LIMITS GALORE!!

Boarding and loading up of the PEACE on Thursday evening for our September two-day went fairly well, with early and late arrivals -- some REAL late arrivals. Bob S arrived -- a miracle in itself under his circumstances -- and then left for place unknown, only to miss the boat departure. As a result, he was a rather obvious shoe-in for the booby prize which until superceded by a greater booby, will henceforth be known as "The Bob Stivers Award." Bob will no longer be eligible for the award!!!

Early Friday morning saw us moving in relatively calm water on the north side of Santa Rosa Island, under this summer's classical grey skies. We finally anchored off Sandy Point at the west end of Santa Rosa in the Little Wilson's area but, unfortunately, the CONCEPTION was on our pinnacle. Visibility was in the 40 foot range with no current and 60 degree (plus or minus a few degrees) temperature. There were some scallops taken, but this was your large fish dive -- most of us were sans spear guns!!! With CONCEPTION hanging on we elected to run over to San Miguel and anchored on the south side just off Crook Point. This was a pretty dive, but was somewhat disappointing for the ardent game takers. Visibility and temperature were similar to the first dive. We then moved further west -- the furthest west I have been on San Miguel -- and dived the Judith Rock area. Visibility dropped to about 25 feet and the temperature dropped a degree or two. Onesies and twosies of nice fish, abs and scallops were the order.

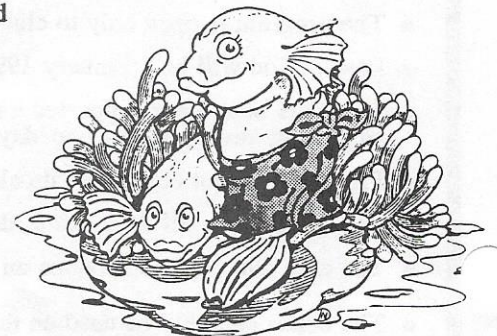
Time to get serious, so back to Little Wilson's and this time to "Le Spot," albeit in suprisingly choppy water with a fairly good current running. This was a strong intermediate to advanced dive. Most of our group limited out on good sized scallops before a rather sporty return to the mother ship and the "E ticket" ride on (and off!) the swim step. We cruised over to Cuyler's on the north side of San Miguel and made our fifth and final first day dive on the inside of Prince Island. This dive yielded a real nice halibut for Michael B.

We anchored in tight for the overnight at Cuyler's with the wind picking up. Dinner was just spectacular with a full prime rib spread, salad, baked potatoes, veggies, hot horseradish, etc., etc. The hot tub, the VCR, and the games all got a good work out, with most of the group retiring to their respective bunks by 10:30 PM. By now, the wind was blowing the bubbles off the hot tub, and from the galley it looked like a snow blizzard!

About 6:30 AM we began the day's activities by performing several giant circles trying to break the anchor loose with much grinding of the winch and teeth. Once on our way, we began to hit the anticipated waves and a few sprayed over the boat -- however, Mike R pressed on and within 20 minutes we were anchoring on the exposed rock area of Wilson Rock. Again, this was an advanced dive, primarily because of surface conditions. Once down the anchor line the pinnacles and crevices of the underwater structure came into view and with 30-40 foot visibility diving was superb. Scallops were the primary order, mostly above 80 feet, with yours truly picking up a 9-1/2" beauty. Most either limited out for the second day or got close -- not to worry, more later.

After some discussion as to whether we should head for Richardson's Rock, we decided not to be greedy and headed to Harris Point on the north side of San Miguel. Great spot, with multiple choice -- up on the reef for scallops and fish, bottom of the reef for abalone, and out on the sand for halibut. Visibility was about 40 feet with no current. With limits everywhere we cruised back to Santa Rosa, anchoring on the north side between Brockway Point and Talcott. Wilson Rock is a world class dive and this spot had a world class kelp bed!?! There was no current, 25 foot visibility, but it was dark down there due to the kelp canopy. Not much game here so most divers cut short the bottom time and hit the hot tub and/or the shower.

The cruise back to Ventura was uneventful. We had a fantastic trip with great diving, outstanding food (including Chinese [complete with chopsticks!!] and Mexican), good friends and the best host and hostess in Bill and Cheri Magee. The crew did its usual first class job. We decided not to award any prizes -- the booby was a shoe-in anyway, but runners up included: Joe Z - jumping in, no fins; Peter L - tank fell out of backpack onto deck (repeat performance); Cathy G - installed first/second stage backwards, twice; Dan P - jammed regulator under BC; Wes S - for spraying silly string over everybody; and Noreen H - making the worst grunting noises imaginable. There were no hero candidates and it was good to see a few new faces - Joe Z, Frank W and Greg M. See you all on the PEACE in December -- the fun dive!! Oh, by the way, Bob S picked up his gear, arriving JUST in time, before it was split up amongst the Executive Committee.



FOR THE RELATIVE BEGINNER — TANK INSPECTIONS & MARKINGS

Scuba tanks are the only facet of sport diving regulated by the government. The Department of Transportation (DOT) monitors the manufacture, inspection, and use of all high pressure cylinders (which is what a scuba tank is) that are transported across state lines by common carriers, and requires a hydrostatic (pressure test) every five years. As part of the dive industry's self-regulation, most air stations will not fill a tank unless it has passed an annual visual inspection. You can find all of your tanks pertinent information stamped on its neck.

Annual Visual Inspection If your tank is more than a year old, it should have a sticker that gives the date of its last annual visual inspection. During the examination, a trained inspector looks for interior corrosion and moisture, which must be removed, and for any exterior damage that might compromise the tank's integrity. If there's any question about the tank's integrity, the cylinder will be pressure tested.

Hydrostatic Test Every five years your tank must be filled with water, submerged in a special water-filled testing vessel, and pressure tested above and beyond its working pressure. For most tanks, the water (hydrostatic) pressure inside the tank is increased to five-thirds the tank's normal working pressure. For high pressure cylinders, it's increased to three-halves the normal pressure (around 5250 psi). The tank actually expands at these pressures, and the amount of water the tank displaces in the test vessel is measured and must stay within limits for the tank to pass. Tanks that fail are condemned. Those that pass are stamped with the test date.

Tank Markings Most of what you'd want to know about a scuba tank is stamped into the metal on its neck. For example:

DOT 3AA 3000+

7635263 LUXFER 6<>90

Regulating Agency DOT (Department of Transportation) or CTC

(Canadian Transportation Commission).

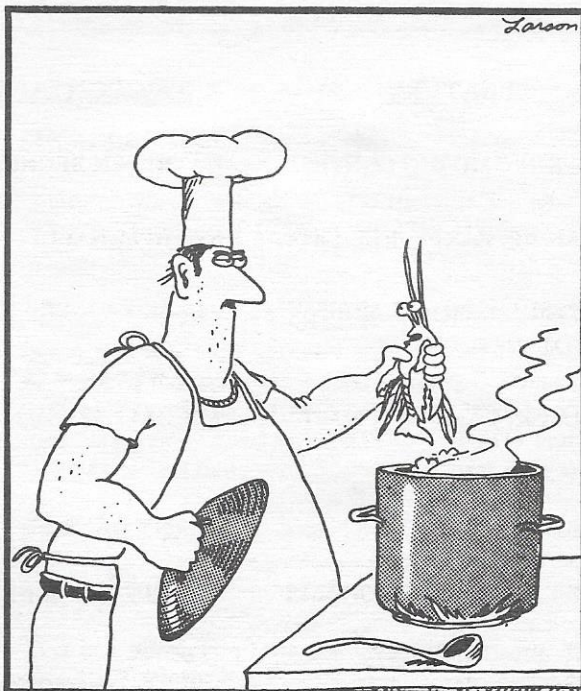
Metal Type Generally speaking, 3AL designates aluminum and 3AA indicates steel.

Working Pressure New steel tanks may carry a + next to the working pressure indicating that they may be filled 10 percent over the rated capacity. So 3000+ means the tank may be filled to 3300 psi. This overfill allowance may be reduced at the first hydrostatic test, and would be indicated by removal of the + sign.

Serial Number You should record this number in case your tank gets stolen or hard to identify in a crowd of tanks.

Manufacturer This is the original manufacturers designation.

Hydrostatic Test Date The month and year of the last hydrostatic test are separated by the tester's identification mark. The date is re-stamped with each new test. A tank that fails has the date stamped out.

Wild Wave/Charisma/Encore - 22nd Street Landing

South on Harbor freeway, left on Gaffey, left on 22nd Street, down the hill and park in designated areas.

Peace - Ventura Marina

North on Ventura freeway to Victoria Ave. in Ventura. Turn left onto Victoria and continue to Olivas Park Drive. Turn right and continue all the way down toward the beach and across Harbor Drive; go to the left on to Spinnaker Drive. Look for Milano's Italian Restaurant and turn right into the parking area. If you get to the end of Spinnaker, turn around and take the second left. Park adjacent to the berth (Slip #20) to unload, then park overnight in the last row adjacent to Spinnaker Drive.

DIVE BOAT POLICY

A club member may, but is not required to, have a boat deposit on file with the club. A club member may make a reservation on an upcoming dive as follows:

- Unconfirmed reservations may be made for any boat dive at any time. To confirm a reservation, payment in full must be received.
- For single day dives, divers holding an unconfirmed reservation will be called 3 weeks prior to the dive and advised that payment in full is required no later than 15 days prior to the dive to be confirmed. Dive boat deposits will be considered as payment in full.
- For two day dives, divers holding unconfirmed reservations will be called 5 weeks prior to the dive and advised that payment in full is required no later than 30 days prior to the dive to be confirmed. Dive boat deposits may be used as part of the payment in full.
- If payment in full is not received by the deadline, the diver may be replaced by a wait listed diver who has paid in full.

Any reservation may be cancelled two weeks prior to a dive with a full refund. Cancellations will not be accepted within two weeks prior to the dive unless a diver holding a reservation can sell or transfer their reservation to another qualified diver. The dive reservationist will assist in this process, but is not responsible for providing paying alternates. When confirmation is received by the dive boat reservationist that a cancelling diver is being replaced by another qualified diver, the replacement diver is then fully responsible for the cost of the dive.

If a diver has a deposit on file with the club and uses that deposit to secure a reservation on a boat dive, he may not use that deposit to secure additional dives until he has paid the club for the first dive. Two years after a diver has ceased to be a member of the club, his unclaimed dive boat deposit will be forfeited to the club. Only Sea Diver club members and members of other selected clubs may make boat dive reservations prior to one month before a scheduled boat dive. Partial refunds from boats which do not make the advertised dive location will be passed on to members who request them within two weeks of the dive.

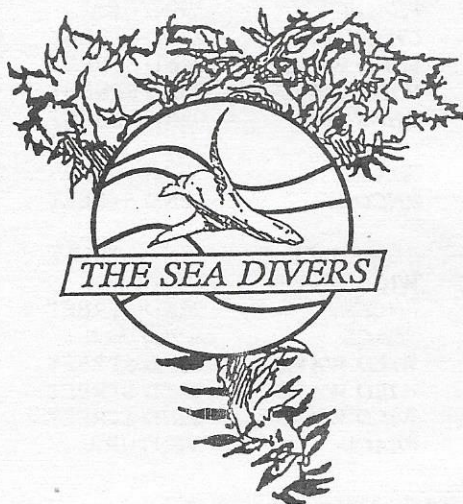
