
WRITING FOR THE SEA DIVERS NEWSLETTER



We hope you'll join us for a fast trip on the WILD WAVE from 22nd Street to SAN NICOLAS in search of those somewhat elusive big LOBSTER. Our dive plan includes an early morning night dive so it is imperative that you include chem-lights and at least one dive light in your gear. For those of us that are not so lucky in the LOBSTER stakes, FISH provide a nice alternative with many different species to play with. Although not the prettiest under water environment, SAN NICOLAS can provide excellent opportunities for VIDEO or PHOTOGRAPHY. The boat will depart at approximately 12:01 AM on Saturday.

As of this writing, the dive light prize for the first 8 pound BUG is still unclaimed -- SAN NIC could do it for someone!!!!

Diving around SAN NICOLAS is suitable for all skill levels with ocean cooperation. Relative beginners should check with The Sea Divers diversaster on duty before making a deep or potentially difficult dive. Our trip back will include late lunch of BBQ steak, baked potatoes, etc., etc., etc., with a modicum of "goormette" wine for those so inclined. Dear Sirs:

I feel compelled to respond to the continued irresponsible journalism which your organization has displayed. You have a responsibility to verify the information you put in print before you mail it out to thousands of divers and organizations. These people believe what they read in print.

It is <u>you</u> who are not up to date on the issues you discuss. In particular response to your letter to the Sea Divers Club, dated 10 November 1991:

1. The Federal Boat User fee <u>has not</u> been repealed. You <u>erroneously</u> reported that this fee was repealed in your newsletter "Visibility," Vol. 8, #7-9, Summer 1991.

The attached letter from Congressman Mel Levine, dated 19 December 1991, indicates that the repeal bill will come up for vote by Congress in 1992. Meanwhile, boat owners are out another \$25 - \$100 as of January 1, 1992.

- 2. It is <u>most certainly</u> illegal to disturb any shipwreck in California waters! Don't take my word for it, have competent legal counsel interpret for you Public Resources Code §§6313 and 6314, or read the attached interpretation issued by the California State Lands Commission. "Recreational Recovery Permits" are the only legal avenue a sport diver may utilize to recover small objects from wrecks (Public Resources Code §6309); however, since issuing those permits is not on the State Lands Commission agenda, there currently is no legal way sport divers may disturb <u>any</u> shipwreck.
- 3. If the Coastal Extension Act (HR 536) is not backed by USOA, I suggest you <u>respond</u> to Discover Diving's article on page 95 of their May/June 1991 issue. I would certainly be interested in learning how Mr. Keatts confused USOA's involvement with this bill.

It is important that <u>all</u> divers oppose further restriction of diving freedoms whether each of us is personally involved with the particular activity affected or not. The passage of the Shipwreck Protection Act and subsequent State legislation resulted in a serious loss of our freedoms and yet another increase in wasteful government bureaucracy.

Let's not make matters worse: oppose HR 536.

BUGS, SCALLOPS, FISH AND FUN!

Another great trip on the PEACE! Our frequent diver bonus trip/Xmas party boat left the Ventura Marina dock at about 3:00 AM Friday, 13 December 1991 ("Friday the 13th Part XYZ"). With calm conditions, Captain Mike R decided to make a straight shot at Talcott Shoals arriving at the eastern end of the shoals a little after 8:00 AM. The first dive was in about 80 feet of calm, 54 degree water, with no current, and 80-100 foot visibility — no problem seeing the boat from the bottom!! This dive yielded but one lobster. With each subsequent move, we edged closer to Sandy Point on the northwest tip of Santa Rosa making dives in 70 feet, 60 feet and finally 50 feet, where the surge was beginning to reduce visibility significantly and and made diving sporty. The sun was out all day, making on board conditions quite comfortable. Hot water from the hot tub into the wet suit helped! Bugs were reluctant to come on board, but slowly but surely the numbers mounted.

We rounded Sandy Point and cruised down to Bee Rock on the east side of the San Miguel Passage making a dive in surgy water up to 45 feet deep. Visibility was surprisingly good at 30-40 feet. Moving south and east we made our sixth of the day near South Point in (again) 45 feet of water. Our seventh — night dive — was at our overnight anchorage off Johnson's Lee (aka McGee's Lee). Only one or two souls made the night dive, the rest of us chosing to exercise the hot tub and our party mood. Full dinner, with all the trimmings, culminated an excellent day of diving and weather. The party animals "tubbed" until about 11:00 PM with the odd "streaker" and "mooner" being observed throughout the evening.

On the second day, per plan, our diving began leisurely at about 8:00 AM in 80 feet of 70-80 foot visibility water. Temperatures had not improved!! More bugs began to appear and our second dive just to the west of Ford Point in 70 feet of water netted the most of any dive so far. At this point we were collectively closing in on 20 bugs, mostly grabbed by the half dozen or so "bugites" on board. We also had a nice fish take.



For the rest of us, Bill McG cruised the "Scallop Spot" just south of Skunk Point on the east end of Santa Rosa Island. Daily limits of 10 scallops each were relatively easily obtained in 25-30 feet. We did note, however, that the reefs were beginning to show obvious signs of depletion as the scallops were a little more difficult to find and in general smaller than previous takes. There was just time for one more dive in Beecher's Bay near the northwest anchorage. By now most of the group were showering and hot-tubbing, but the ardent few were rewarded by more lobster, including a 7-3/4 pound beauty for Pete K and Paul K — real close to picking off the \$50 dive light prize for first 8 lb'er.

As planned, we had fully circumnavigated Santa Rosa Island making a total of eleven dives in generally great visibility, calm and currentless water. Only the water temperature could have been better! The PEACE did its usual excellent job and even the December weather was great . . . what more could we ask for?

We did not make any specific awards; however, Kathi Mc gave out lots of little furry animals for Xmas. The dive light prize was an "almosy," but the boobie candidates for the Bob Stivers Award were "weak." However, of note were: myself (AP) for leaving my keys in the trunk lid of the car for five hours, then remembering where they were two minutes before departure; Pete K for pouring booby-trapped ice cold water into his wetsuit; Sandy M for attempting a dive with no weight belt and Kathleen B for attempting a dive with her air turned off!!! Honorable mentions go to Paul K for a spectacular high, wide and handsome drive from Newport Beach to Ventura; Paul K (again) for a dinner roll routine at The Shores Restaurant and Paul K (again!) and Wes S for doing a night dive on McNally Pinnacles just off McGee's Lee without a proper dive plan or a divemster on duty!!?? I know we all enjoyed . . . hope to see you on an upcoming dive soon!!

Wild Wave/Charisma/Encore - 22nd Street Landing

South on Harbor freeway, left on Gaffey, left on 22nd Street, down the hill and park in designated areas.

Peace - Ventura Marina

North on Ventura freeway to Victoria Ave. in Ventura. Turn left onto Victoria and continue to Olivas Park Drive. Turn right and continue all the way down toward the beach and across Harbor Drive; go to the left on to Spinnaker Drive. Look for Milano's Italian Restaurant and turn right into the parking area. If you get to the end of Spinnaker, turn around and take the second left. Park adjacent to the berth (Slip #20) to unload, then park overnight in the last row adjacent to Spinnaker Drive.

DIVE BOAT POLICY

A club member may, but is not required to, have a boat deposit on file with the club. A club member may make a reservation on an upcoming dive as follows:

- A) Unconfirmed reservations may be made for any boat dive at any time. To confirm a reservation, payment in full must be received.

 B) For single day dives, divers holding an unconfirmed reservation will be called 3 weeks prior to the dive and advised that payment in full is required no later than 15 days prior to the dive to be confirmed. Dive boat deposits will be considered as payment in full.
- C) For two day dives, divers holding unconfirmed reservations will be called 5 weeks prior to the dive and advised that payment in full is required no later than 30 days prior to the dive to be confirmed. Dive boat deposits may be used as part of the payment in full.

 D) If payment in full is not received by the deadline, the diver may be replaced by a wait listed diver who has paid in full.

Any reservation may be cancelled two weeks prior to a dive with a full refund. Cancellations will not be accepted within two weeks will assist in this process, but is not responsible for providing paying alternates. When confirmation is received by the dive boat reservationist that a cancelling diver is being replaced by another qualified diver, the replacement diver is then fully responsible for the cost of the dive.

If a diver has a deposit on file with the club and uses that deposit to secure a reservation on a boat dive, he may not use that deposit to secure additional dives until he has paid the club for the first dive. Two years after a diver has ceased to be a member of the club, his unclaimed dive boat deposit will be forfeited to the club. Only Sea Diver club members and members of other selected clubs may make boat dive reservations prior to one month before a scheduled boat dive. 
