#### FOREST IN THE SEA - CONTINUED

Today scientists continue to experiment with ways to restore the forests to their rightful magnitude. The conclusion of this presentation will run about 20 minutes.


#### WRITING FOR THE SEA DIVERS NEWSLETTER

Our first dive on the ENCORE in 1992 is to NINE FATHOM REEF and SAN CLEMENTE ISLAND. We will leave in the early AM from 22nd Street and run overnight to make our first dive at NINE FATHOM REEF. This is one of the most spectacular dives in the southern area, with purple coral, game, sea lions and other sea life to view and maybe PHOTOGRAPH or VIDEO.

This is the Sea Divers' third dive on the ENCORE — the largest boat in the Southern California fleet. The ENCORE is 80 feet long, 25 feet wide, has 12 staterooms, ladies dressing room, 45 seat galley, walk-in freezer, large sundeck and color TV/VCR. We are limiting the trip to 32 divers which is extremely comfortable on a boat of this size.

Following the NINE FATHOM REEF dive, we will cruise south and east either on the backside or frontside of SAN CLEMENTE picking different spots from those we dove in January (on the frontside). The diving will provide a variety of underwater topography in what is typically excellent visibility. Water temperatures will have risen significantly, making for very comfortable conditions. Game takers will not be disappointed, with FISH, SCALLOPS and ABALONE available. Those who just like to dive and enjoy the scenery can't pick a better dive. This trip is suitable for all skill levels. There will be typical Sea Diver goodies added to this charter.



#### NOT SPECTACULAR — BUT A NICE DAY OUT

CHARISMA left the 22nd Street dock at little after 6:00 AM on 22 April 1992 with a full load of divers heading for Farnsworth Banks. The trip over was close to calm and we arrived over the Banks at 9:15 AM, ten or so minutes behind WILD WAVE which was anchored on the 55 foot high spot. Skipper John H negotiated with Joel I on the WILD WAVE for our divers to use the WILD WAVE's anchor line onto the reef. This worked out fine except that Joel I had just missed the high spot and the anchor line was about 20-30 feet to the east — but close enough! Visibility was not great but acceptable at 15-25 feet. There was no current and water temperature was in the mid 60's — great for April! Farnsworth was as spectacular as ever —— albeit not as clear as usual

Following the dive CHARISMA headed towards Cat Harbor to attempt a dive just West of Lobster Bay, but visibilty did not appear acceptable so we motored around the West End into much clearer water on the front side. The second (and third if you were quick!!) dive was typical Catalina with rocks and boulders supporting a good kelp growth in the 20-40 foot depths and less of both as depth increased up to 120 feet. We noted one green abalone at about 70 feet which was 5-15/16" across!! Again, there was no current, and water temperature was close to 65 degrees F.

We moved about one half mile east, close to Strong Point, for our third (and/or fourth!) dive of the day. With depths up to 60 feet, the topography was quite different with large square reef structures prevailing. The water was obviously (yet suprisingly) cooler than the first two dives with 62 degrees F as the average. Still warm for April! We were entertained by a 6 foot tiger shark "playing" with several fast moving fish. Towards the end of this dive the current appeared from nowhere causing several divers to huff and puff back to the boat. Also on this dive one of the crew members speared a 35 pound white sea bass SKIN DIVING --- nice fish.

The cruise back to 22nd Street was uneventful with some of our group sacking out, others reading, socializing, watching TV and/or partaking of our post-dive beverages. We had no real boobie, hero or game award candidates so we elected not to force the issue, keeping the award for next time. It was a real nice day out, very relaxing, pleasant (if not spectacular) diving and definitely beat working. Thanks for your support. April is a tough month!!



#### Dear Krabby

Dear Krabby,

I recently purchased a PADI Wheel to calculate my available bottom time for multi-level dives. I couldn't afford or justify the cost of a dive computer so I thought that this would be an inexpensive alternative. I am having a problem however, understanding exactly how to use and interpret this device. Any suggestions?

Asleep at the Wheel

Dear Ass...I mean asleep,

You are correct in that the PADI Wheel can be an inexpensive substitute for a multi-level dive computer. You'll also be glad to know that you're not alone in your confusion with it's operation. But you're in luck! A University in your area, UCLA, has recently started both a 4-year Bachelor of Scuba-PADI Wheel (BSPW) and a more advanced 2-year Master of Scuba-PADI Wheel (MSPW). You will however, need to complete the MSPW course in it's entirety to fully grasp multi-level dives. The BSPW program only covers the basics of the PADI Wheel and square dive profiles. One other alternative is the UCLA extension course called "Multi-Level Operational Procedures for the PADI Wheel". course can be completed in just 1 year going only 3 nights a week and all day Saturday and Sunday.

Now, I know what you're thinking. The BSPW, MSPW and extension course all cost thousands of dollars and take a long time to complete...so where does that leave you?? Well, it leaves you with a tacky little piece of plastic that doesn't

even make a good paper weight and the growing conviction that you should have put a crowbar in your wallet and paid for the damn computer in the first place!

Dear Krabby,

I am a fairly experienced diver and yet I notice that I seem to have a very poorly developed sense of direction. I've taken all of the navigation courses but, to no avail. I always come up several hundred yards from the boat. Can you help me?

Lost in the Deep

Dear Lost,

I personally would suggest one totally infallible method for locating the boat...follow your bubbles!! That's right, in case you haven't noticed your bubbles always go up (unless you're sucked into the inlet of a power plant but, that's another problem). ## AN EXPERIENCE . . . LESSON WELL LEARNED . . . . . . I LEARNED ABOUT DIVING FROM THAT . . . AN ALMOSSY!!!



Farnsworth. Well known for accidents over the years. A dive spot to be taken very seriously.

I arose at about 5:45 AM and rode over on CHARISMA to Farnsworth mostly in the galley, taking a couple of sessions to prepare my dive gear. I noticed that the band on my dive watch was split on one side so I took it off and stowed it — first indication of a tough day! As CHARISMA anchored alongside WILD WAVE, I activated my dive computer, made final checks and put on my tank, etc., at which time I noticed my trusty (up to now, very reliable) computer was "scrambled." Shit! Off with the gear; disconnect computer; connect and check out back-up set up (non-computer) and decide to forgo the dive based on instructor's long ago words and my own statements: "If it's going wrong, don't dive!" — and it was definitely going wrong.

But wait, we only dive Farnsworth every other year, and after all, what is back up equipment for . . let's go diving. I completed suiting up, entered the water and began my decent down WILD WAVE's anchor line. When I reached 55-60 feet — no pinnacle (Joel I had missed to the left by 20-25 feet). I continued down until I was at just over 80 feet, checking my back up set up all the way down. It was working just fine. Still no pinnacle. Looking around I observed the side of the reef about 20-25 feet to my right. I turned and swam over to the wall, went to take a breath, and nothing. I mean like NOTHING!?#@!? NO AIR, ZIP, NADA.

Surprisingly – and you honestly don't know until it happens – no panic. I didn't hesitate, dropping my weight belt – complete with dive light, ab iron, gauge, goodie bag and all – into the 180 foot plus depth, and began my emergency ascent. During the L.A. County Advanced Diver Program in 1981 I made a planned controlled emergency ascent from over 90 feet, but obviously that was 11 years ago; however, still good psyche for the very moment – but this was far from planned. At about 50 feet I tried my AIR II –– still NOTHING –– but by now I felt comfortable and was becoming confident that I was making it and would make it. I thought about breathing out of my BC but by the time I got set up the surface was at hand and I broke into the morning air with no problem, but probably too quickly for the text book.

I waited a few seconds for any symptoms of embolism, signaled to Jack B the divemaster that I was OK, then swam over to CHARISMA and pulled myself back on board. Jack's eyes nearly bugged out when I explained what had just happened — but I was OK — experience and advanced training had fully paid off. In retrospect — things WERE going wrong — I probably should have stayed with my initial thought of foregoing the dive. The back up set up was apparently a non-factor — as far as I can discern. It appears that I had a major malfunction in either my tank valve or the first stage — the VERY rare but possible equipment failure. Experience AND advanced training were very significant, you can't get enough of either. In the midst of considering BC breathing, I made one non-critical error by not slowing down through the last 20–30 feet before breaking the surface (small error under the circumstances).

Would a buddy have helped? I think not – most of us don't practice with a buddy who could have been several critical feet away and tests have shown it takes at least 20 precious seconds to "hook up" when buddies are in close proximity and used to each other. By then I was well on my way to the surface. I believe in the buddy system but I also believe you have to be fully responsible for your own well being.

Thanks Billy G, thanks LACC ADP, thanks weight belt (wherever you are!!!). Spare Air -- now there's a thought.


#### BEACH DIVE/BOUILLABAISSE COOKOUT/POTLUCK

#### Wild Wave/Charisma/Encore - 22nd Street Landing

South on Harbor freeway, left on Gaffey, left on 22nd Street, down the hill and park in designated areas.

#### Peace - Ventura Marina

North on Ventura freeway to Victoria Ave. in Ventura. Turn left onto Victoria and continue to Olivas Park Drive. Turn right and continue all the way down toward the beach and across Harbor Drive; go to the left on to Spinnaker Drive. Look for Milano's Italian Restaurant and turn right into the parking area. If you get to the end of Spinnaker, turn around and take the second left. Park adjacent to the berth (Slip #20) to unload, then park overnight in the last row adjacent to Spinnaker Drive.

#### DIVE BOAT POLICY

A club member may, but is not required to, have a boat deposit on file with the club. A club member may make a reservation on an upcoming dive as follows:

- Unconfirmed reservations may be made for any boat dive at any time. To confirm a reservation, payment in full must be received. A)
- B) For single day dives, divers holding an unconfirmed reservation will be called 3 weeks prior to the dive and advised that payment in full is required no later than 15 days prior to the dive to be confirmed. Dive boat deposits will be considered as payment in full. C)
- For two day dives, divers holding unconfirmed reservations will be called 5 weeks prior to the dive and advised that payment in full is required no later than 30 days prior to the dive to be confirmed. Dive boat deposits may be used as part of the payment in full. If payment in full is not received by the deadline, the diver may be replaced by a wait listed diver who has paid in full. D)

Any reservation may be cancelled two weeks prior to a dive with a full refund. Cancellations will not be accepted within two weeks prior to the dive unless a diver holding a reservation can sell or transfer their reservation to another qualified diver. The dive reservationist will assist in this process, but is not responsible for providing paying alternates. When confirmation is received by the dive boat reservationist that a cancelling diver is being replaced by another qualified diver, the replacement diver is then fully responsible for the cost of the dive.

If a diver has a deposit on file with the club and uses that deposit to secure a reservation on a boat dive, he may not use that deposit to secure additional dives until he has paid the club for the first dive. Two years after a diver has ceased to be a member of the club, his unclaimed dive boat deposit will be forfeited to the club. Only Sea Diver club members and members of other selected clubs may make boat dive reservations prior to one month before a scheduled boat dive. Partial refunds from boats which do not make the advertised dive location will be passed on to members who request them within two weeks of the dive.


