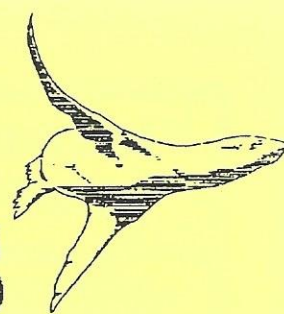


# THE SEA DIVERS

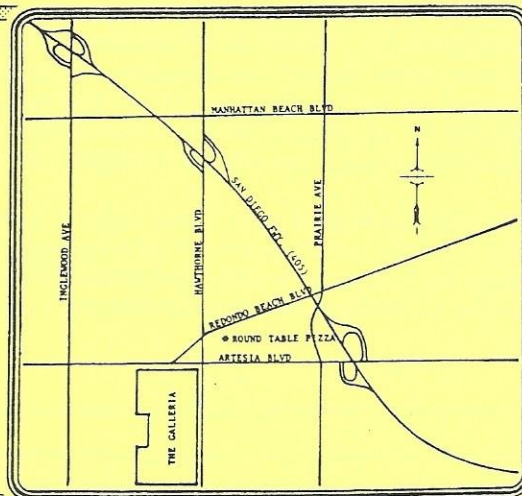
### WRITING FOR THE SEA DIVERS NEWSLETTER

RICHARDSON'S ROCK does not feature on our dive schedule very often. In the past ten years we were scheduled for September '84 (PEACE), September '86 (BOLD CONTENDER), September '88 (PEACE) and September '89 (PEACE). We are zero for four!! In '84 and '88 it was weather, in '86 the boat moved to Ports O'Call and in '89, PEACE only had one working engine!! SO WE ARE DUE – RIGHT?

RICHARDSON'S ROCK, unlike BEGG or WILSON, has a large area which peaks 53 feet above the ocean. This peak is white topped (for obvious reasons) and is located WNW of SAN MIGUEL Island. The surrounding area is up to 150 feet deep and the walls, plateaus and canyons are home to a tremendous variety of sea life, which, due to RICHARDSON's remoteness, is relatively undisturbed. Purple coral can be found from 20 feet on down and SCALLOPS, generally below 50 feet and deeper.

For the ADVANCED diver there are small and large open caves at 80 feet and beyond which have additional SCALLOP condominium groupings inside. Large FISH inhabit the environs as do many other moving "objects" -- watch out what you spear!!

As stated above, RICHARDSON'S ROCK is a FULLY exposed dive area. When conditions are favorable, it provides some of the most memorable diving experiences in Southern California, and can on some occasions be dived by all skill levels. Note, however, that this is typically an advanced dive -- Sea Diver divemasters will assist in assessing diver capabilities against the specific conditions.

Depending on weather, etc., we will shoot for RICHARDSON'S on the first or second day -- should we be so fortunate, WILSON ROCK could be either a first or second day addition. For the rest of the diving we plan to "circle" SAN MIGUEL and hit -- not literally -- the western limits of SANTA ROSA primarily for red ABALONE. We plan 5 to 7 dives the first day and 3 to 5 dives the second day. LOOKY-LOOS/ PHOTOPHILES/VIDEO NUTS will have a plethora of spectacular spots to enjoy.

Diving on the PEACE with The Sea Divers in September should make for an outstanding trip. Water temperatures are high this year and typically are near peak in the September/October timeframe, so this just may bring "warm water" diving for those who sign up (and go!). Call Kathi (McNally) at (310) 370-1657 for early sign up. We anticipate a full boat and as we are overdue, success at RICHARDSON'S and SAN SAN MIGUEL. NOT A TRIP TO MISS!!

Boarding will begin at 7:00 PM for a 2:00 AM departure.

BUG SEASON! This year the season opener has changed and begins Saturday, 3 October 1992, instead of Wednesday, 7 October 1992. 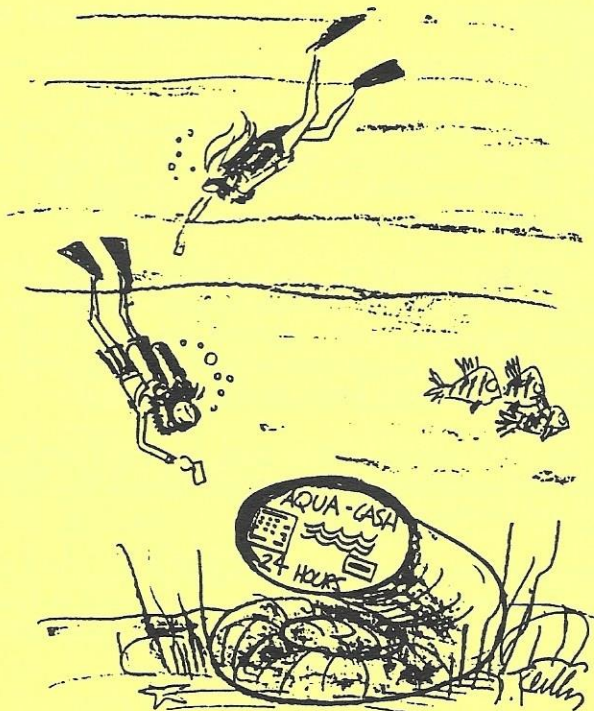


## JUST 15 YEARS AGO . . .

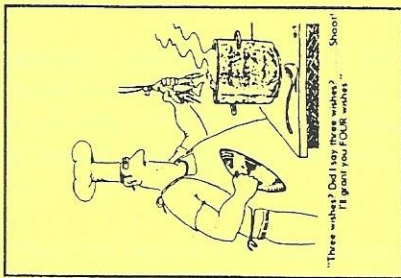

## THE SEA DIVERS INTERIM NITROX POLICY

As many of you may be aware, the use of Nitrox (also known as enriched air and Safe Air) in sport diving is gaining significant acceptance, particularly on the East Coast and at some specialist resorts. Our club's collective knowledge within the Executive Committee, Instructor/Divemaster core, dive stores and advanced divers is limited to articles and discussions in dive magazines and other publications. As a result, and until we gain further training and/or insight into use of Nitrox, the following interim club policy will apply:

- 1) Nitrox may only be used as a separate and fully independent system supplement to a normal air supply and should be used only during the termination/ascent portion of any dive. Use of Nitrox only is not allowed under this interim policy.
- 2) Diver must show proof of Nitrox use certification and specific Nitrox mix to the divemaster(s).
- 3) Diver must be an advanced diver and a club member.
- 4) Diver must not exceed 1.6 ATA oxygen – i.e., 132 feet while carrying Nitrox I (32% oxygen), or 114 feet while carrying Nitrox II (36% oxygen).
- 5) Depth and bottom time limits must be based on AIR ONLY calculations using computers, Navy tables, etc. This is per Application 1, page 71/72 of the ANDI Manual.
- 6) Diver must log actual depth and bottom times with the divemaster upon return to the boat (or beach).

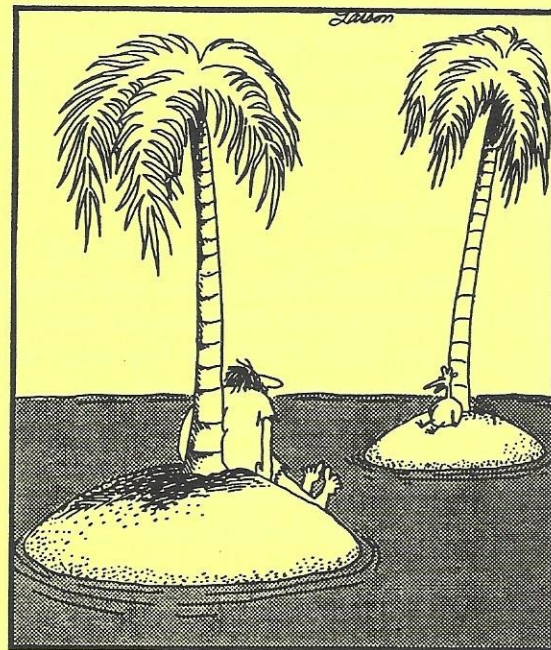
We realize that we will be faced with the obviously fast-growing use of Nitrox and as a safety-minded yet forward-looking club, we will develop our knowledge and understanding in good time. For now we believe the policy here stated will cover anticipated diver desires within the foreseeable future. At this time, we view the use of Nitrox as a method for **INCREASING SAFETY MARGIN RATHER THAN BOTTOM TIME**. We are not against the use of Nitrox-- we are just not well versed and/or sufficiently knowledgeable at this time. Divemaster knowledge/certification/insurance issues are, of course, of some concern from a liability standpoint.

### AGENCY POSITIONS

(From SCUBA DIVING, May/June Issue)

Certification agencies are taking a hard look at enriched air. At presstime, here's where they stood:

- NAUI** NAUI recognized enriched air as an advanced specialty. Active NAUI instructors may teach enriched air courses with NAUI approval if they are also active and rated with ANDI or IAND. NAUI's insurance covers instructors teaching NAUI-approved enriched air courses.
- NASDS** Recognizes enriched air as an advanced specialty for recreational divers, offers insurance through retailers.
- PADI** PADI said it does not sanction gas mixtures other compressed air for recreational diving. Enriched air is viewed as a highly-specialized activity requiring specific training and special dive tables.
- SSI** Has no plans to offer specialty certification at this time.

## LEGISLATIVE NEWS

Many of you may have seen newspaper articles lately like the Press Telegram article of June 22 sporting the by line "Divers are 'raping' ocean, group says." This press has been generated by Assembly Bill 2261 introduced by Torrance Assemblyman Gerald Felando and backed by the Catalina Conservancy Divers' group. The bill is intended to stop the commercial collection of aquarium specimens on the front side of Catalina. Specifically, the bill establishes still permit fees for collectors and wholesalers, outlaws collection at Catalina from Church Rock to the West End, and lists species which can and can't be collected. The bill has no direct effect on sport divers.

A meeting was held August 6 by the Department of Fish & Game to hear arguments against opening lobster season four days early for sport divers. The dive councils took an action to get sport divers to respond to DFG regarding opening week activities. DFG wants to know how many divers go out opening night (first day), and if their going out was only a result of it being a Saturday. Also, they want a daily tally of the number of bugs taken for each of the first four days of the season. Having gathered this data, along with the commercial catch records, DFG will review the matter next August. Expect to hear more on this shortly, as GLACD figures out how to gather this information.

The gillnetting proposition passed last year by the voters of California requires the establishment of four new "ecological reserves" along the mainland coastline by January 1994. One of the areas being strongly considered is the area between Flat Rock Point and Palos Verdes Point on Palos Verdes Peninsula. Many South Bay divers are familiar with this area as being one of the hottest lobster grounds around. At this time, it is totally unknown what impact the establishment of an "ecological reserve" will have on an area; it could range from no impact to a complete closure for game taking. Unfortunately, the use will be decided AFTER the areas are chosen. By then, it may be too late for sport divers to voice their objections. The four areas will be decided upon sometime in October; therefore, the time to act is NOW! Send a letter stating your opinions to:

### *Wild Wave/Charisma/Encore - 22nd Street Landing*

South on Harbor freeway, left on Gaffey, left on 22nd Street, down the hill and park in designated areas.

### *Peace - Ventura Marina*

North on Ventura freeway to Victoria Ave. in Ventura. Turn left onto Victoria and continue to Olivas Park Drive. Turn right and continue all the way down toward the beach and across Harbor Drive; go to the left on to Spinnaker Drive. Look for Milano's Italian Restaurant and turn right into the parking area. If you get to the end of Spinnaker, turn around and take the second left. Park adjacent to the berth (Slip #20) to unload, then park overnight in the last row adjacent to Spinnaker Drive.

### **DIVE BOAT POLICY**

A club member may, but is not required to, have a boat deposit on file with the club. A club member may make a reservation on an upcoming dive as follows:

- A) Unconfirmed reservations may be made for any boat dive at any time. To confirm a reservation, payment in full must be received.
- B) For single day dives, divers holding an unconfirmed reservation will be called 3 weeks prior to the dive and advised that payment in full is required no later than 15 days prior to the dive to be confirmed. Dive boat deposits will be considered as payment in full.
- C) For two day dives, divers holding unconfirmed reservations will be called 5 weeks prior to the dive and advised that payment in full is required no later than 30 days prior to the dive to be confirmed. Dive boat deposits may be used as part of the payment in full.
- D) If payment in full is not received by the deadline, the diver may be replaced by a wait listed diver who has paid in full.

Any reservation may be cancelled two weeks prior to a dive with a full refund. Cancellations will not be accepted within two weeks prior to the dive unless a diver holding a reservation can sell or transfer their reservation to another qualified diver. The dive reservationist will assist in this process, but is not responsible for providing paying alternates. When confirmation is received by the dive boat reservationist that a cancelling diver is being replaced by another qualified diver, the replacement diver is then fully responsible for the cost of the dive.

If a diver has a deposit on file with the club and uses that deposit to secure a reservation on a boat dive, he may not use that deposit to secure additional dives until he has paid the club for the first dive. Two years after a diver has ceased to be a member of the club, his unclaimed dive boat deposit will be forfeited to the club. Only Sea Diver club members and members of other selected clubs may make boat dive reservations prior to one month before a scheduled boat dive. Partial refunds from boats which do not make the advertised dive location will be passed on to members who request them within two weeks of the dive.

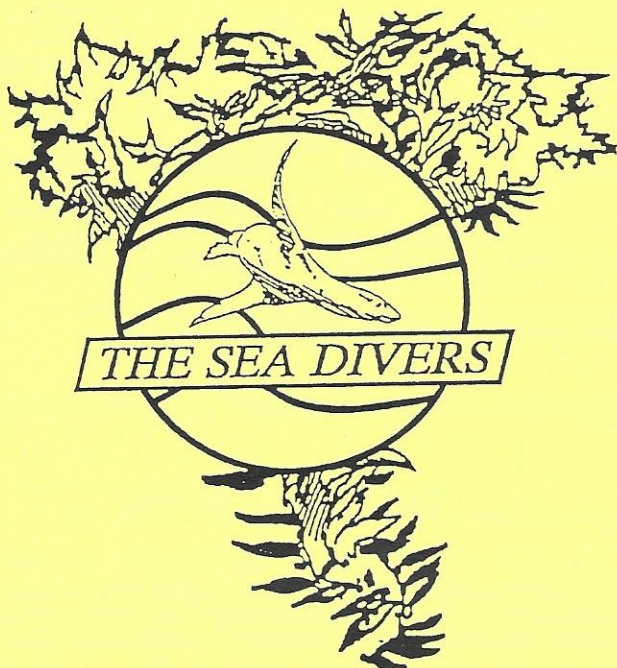
