LA PAZ, MEXICO TRIP MINI-REPORT

From July 14-18, 1998, seven Sea Divers in a group of 18 visited La Paz, Baja, Mexico. We stayed at La Concha Resort. Each morning, we were picked up from the resort's dock by the Rio Rita, the old dive boat that used to be located in San Pedro. We used 3 Aluminum 80 ft.³ tanks per day. The two trip diving highlights for Peter L. were seeing 10 large hammerheads on one dive (at 60 feet depth, up to 10 feet long, as close as 20 feet away) and repeatedly stroking a 500 pound male sea lion literally from head to tail. Others saw as many as 25 hammerheads on one dive. Water temperatures were in the range of about 75°-83° F and currents were sometimes strong. Most diving was done in the 20-80 foot depth range and visibility was usually in the 40-80 foot range. A trip video is being prepared, and will be shown at a future Club meeting.

WRECK DIVING

16 AUGUST 1998 (Sun)

OLYMPIC & AVALON WRECKS and PALOS VERDES

This will be the club's first wreck dive since 1991. For this single day charter, we plan to dive the *Olympic*, which is a relatively deep dive, then proceed to the *Avalon* for a somewhat shallower dive. Subsequent to the *Avalon* we will dive a couple of spots off Palos Verdes in yet shallower water.

We will leave the dock at 7:00 AM sharp and head out to the *Olympic* some 3-1/2 miles out from the San Pedro Light at L.A. Harbor. The *Olympic* was built in Belfast, Ireland, and launched in 1877 as the *Star of France*. She was an iron hulled, square-rigged bark of 1,644 tons, 258 feet long and 38 feet wide. Some 63 years later she was rammed amid ships by the *Sakito Maru* about 7:00 AM on 4 September 1940, and sank within minutes with 17 of 24 on board surviving. The *Olympic* lies essentially on the starboard side in about 100 feet of water. The highest part of the bow is about 70 feet below the surface with the bowsprit extending out over the sandy bottom. The midship section is approximately parallel to the sand and is in relatively poor shape, however, mast stubs are visible, as is the deck pump and its large spoked wheels. Also, if you spend a little time on the port side, you can still see the remains of the huge "V", cut by the *Sakito Maru*. The top of the stern is about 80 feet below the surface and this section is between 40 and 50 feet long. The whole wreck is covered with strawberry anemones. It is a fascinating dive.

We will then head off towards Palos Verdes Point and the wreck of the *Avalon* some 15 miles from the *Olympic*. The *Avalon* was built in Cleveland, Ohio, and launched in 1891 as the *S.S. Virginia*. She was a steel hulled, triple deck, twin screw passenger steam ship of 1,985 tons, 265 feet long, and 38 feet wide. Some 69 years later, while being used in salvage attempts of the *S.S. Dominator*, she sank during the night of 18 July 1960, after breaking away from her moorings in a violent storm. There was no loss of life. The *Avalon* rests in about 70 feet of water, between and parallel to the rocky ridges, with the major wreck sections partially on their port side. The relatively intact bow section is some 90 feet from the rest of the wreck, which begins with a debris field that includes steel deck plates and hull ribs. The debris field slowly rises and is connected to the very recognizable stern section. Some sections of the wreck are covered with a variety of sea life.

Wreck diving over, we will begin to work our way around the Palos Verdes Peninsula towards San Pedro, picking two of the best reefs for some relatively shallow diving. Surprisingly to some, marine life flourishes in the area with excellent prospects for spearing several popular and good size varieties of fish, including calico bass. Video and photo enthusiasts will not be at all disappointed with the underwater opportunities in the coves, on the reefs and in the kelp forests. We anticipate a very interesting day out with an unusual selection of dives, that should provide for more than the average charter. The planned itinerary for this September two-day will take us out to San Miguel Island -- as always, weather permitting. Our first dive spot will be on the east side of Santa Rosa Island in a good scallop area. We will loop around either the north or south side of Santa Rosa depending on ocean conditions picking off dives either on the northwest tip (fish and scallops) or the southwest tip (fish).

We then plan to cross the San Miguel Passage onto the south side of San Miguel diving Crook Point, Wychoff Ledge, and Tyler Bight. We will then circle back around the east side of the island for one or more dives before overnighting.

Weather permitting we would hope to tackle Richardson's and/or Wilson Rock, failing that, we will probably dive the lee side of Prince Island. Then we'll begin the run back to the mainland stopping for dives along the north side of Santa Rosa, possibly at Talcott Shoal.

This two-day will provide excellent opportunities for game (fish, scallops) and all kinds of photogenic sea life. Overall there will be dives for all skill levels -- although, the major pinnacles are considered to be for strong intermediate to advanced divers in all but near perfect conditions.

The *Peace* is a great boat just to be on -- diving or not!! At the time of this writing the boat is full with a wait list. Call Curt (Billings) at (909) 945-3461, Fax at (909) 477-2849, or e-mail at curt@diver.net for bunk assignment as you pay in full and to get on the wait list!! Other spots may be available depending on the other half boat sign-ups. DON'T WAIT!! Don't forget the hot tub -- nice!!

CAVERN OR CAVE DIVING ANYONE?

John Delaney and Dave Gunning will be going on a Cavern/Cave Diving trip to the Akumal, Mexico area this coming November. The trip is planned from 21 Nov (day of arrival) to 1 Dec (day of departure). That will allow 8 or 8-1/2 days of diving with 24 hours to off gas before flying. We will be diving with and staying with Aquatech / Villas De Rosa (phone: 011-52-987-59020, e-mail: 105107.2445@compuserve.com). The package includes accommodations (condos on the beach), 3 meals a

day, pick up from and return to the Cancun airport, a vehicle to drive to and from the cenotes (sink holes), tanks and air for two dives per day. The trip coordinator is Larry Dickie (lpdickie@juno.com or 813-573-3612 x224). Larry can provide details on prices and send you information on the cost of certification/training if you are interested in joining in. He also serves as the on site coordinator for resolving any problems and as a guide to the cenotes for the certified divers. My estimate is that the entire trip should run no more than \$1400 plus airfare and Instruction/Certification costs.

There should be sufficient time to take both the Cavern and Intro to Cave courses during this trip. Instruction and certification will be an additional cost —again Larry can provide details or you may contact Aquatech directly. I don't know if Larry will take on the responsibility of arranging your training or not – it is not a normal function of the trip coordinator.

If you or your diving partner do not desire to get Cavern/Cave certified, then you can arrange for guided Cavern tours and/or open water diving on the reefs just off shore. Villas De Rosa has a large diving equipped panga and if they weather permits they can run across the channel to Cozumel.

The Caves and Caverns in this area were dry for millions of years and are fully "decorated" with stalactites and stalagmites. Their beauty is beyond description. Most of the Cavern and Cave diving is relatively shallow (less than 60 feet), allowing long enjoyable dives.

BEGG ROCK AND BANANAS

The overnight run to Begg Rock was calm until about 4:00 A.M. when a strong wind came up and started to churn up some local wind waves. There were little or no swells.

Arrival at Begg saw slightly choppy conditions but well within divable range for most on board. We anchored on the shoulder to the east of the pinnacles. Contact with the reef occurred at about 55 feet, with potential depths well beyond normal sport diving range. Visibility was 50 feet or so increasing to 70 plus just below the 100 foot depth. Temperature decreased from 62°F to 57°F at depth. Scallops galore, most in the 6" to 8" range at 55-75 feet and 7" to 9" at depth. We accomplished three dives at Begg in decreasing surface chop.

We then moved into the San Nicolas environs diving an "unknown" spot on the West End with 45' of water in 20 to 30 feet visibility – not a great spot. The fifth dive and sixth night dive were in Dutch Harbor, our overnight spot with similar conditions to dive four. Water temperature was in the low 60's, with not much game at either spot.

Five A.M. Saturday we were on our way back to Begg Rock. The ocean was calmer than the previous day and we anchored a little farther east. It became apparent that a strong current was running. This made the first dive somewhat strenuous but manageable. Dive two (or three) had little or no current to contend with. Conditions were otherwise much as the day before.

Scallops limits taken and surprisingly few varieties of fish to spear the fifth (or sixth) dive at Begg Rock (in two days) becomes less than challenging. Kathy D. and I decided to go "deep" and try to pick off one "trophy scallop". Deep we went, no trophy!

Bananas were on board, apparently causing a series of non-major events. About a half dozen computers went down, including my primary before the first dive on Friday. Lights, ab irons, game bags, and knives were lost in abnormal numbers. One of the boat compressors died after feeding "tasty" air to many divers. The anchor got stuck. Dived in the worst current in a long time. My face mask floated off my face at 65 feet....plus other sundry stuff. By the middle of the second day of diving the banana user was looking a little concerned!!! Despite having bananas smuggled into his galley the new chef rose above this potential for disaster and managed to prepare several extremely tasty meals. Nice trip!





Great Escape - 22nd Street Landing

South on Harbor freeway, left on Gaffey, left on 22nd Street, down the hill and park in designated areas.

Peace - Ventura Marina

North on Ventura freeway to Victoria Ave. in Ventura. Turn left onto Victoria and continue to Olivas Park Drive. Turn right and continue all the way down toward the beach and across Harbor Drive, go to the left onto Spinnaker Drive. Look for Milano's Italian Restaurant and turn right into the parking area. If you get to the end of Spinnaker, turn around and take the second left. Park adjacent to the berth (Slip #20) to unload, then park overnight in the last row adjacent to Spinnaker Drive.

DIVE BOAT POLICY

A club member may, but is not required to, have a boat deposit on file with the club. A club member may make a reservation on an upcoming dive as follows:

A) Unconfirmed reservations may be made for any boat dive at any time. To confirm a reservation, payment in full must be received. For single day dives, divers holding an unconfirmed reservation will be called 3 weeks prior to the dive and advised that payment in full is required no

later than 15 days prior to the dive to be confirmed. Dive boat deposits will be considered as payment in full. C) For two day dives, divers holding unconfirmed reservations will be called 5 weeks prior to the dive and advised that payment in full is required no later than 30 days prior to the dive to be confirmed. Dive boat deposits may be used as part of the payment in full.

D) If payment in full is not received by the deadline, the diver may be replaced by a wait listed diver who has paid in full.

Any reservation may be cancelled two weeks prior to a dive with a full refund. Cancellations will not be accepted within two weeks prior to the dive unless a diver holding a reservation can sell or transfer their reservation to another qualified diver. The dive reservationist will assist in this process, but is not responsible for providing paying alternates. When confirmation is received by the dive boat reservationist that a cancelling diver is being replaced by another qualified diver, the replacement diver is then fully responsible for the cost of the dive.

If a diver has a deposit on file with the club and uses that deposit to secure a reservation on a boat dive, he may not use that deposit to secure additional dives until he has paid the club for the first dive. Two years after a diver has ceased to be a member of the club, his unclaimed dive boat deposit will be forfeited to the club. Only club members of The Sea Divers and members of other selected clubs may make boat dive reservations prior to one month before a scheduled boat dive. Partial refunds from single day boats which do not make the advertised dive location will be passed on to members who request them within two weeks of the
