

The first dive of our 2001 program is to Santa Barbara Island and Sutil Island. This lobster season Santa Barbara has proven to be one of the best spots in Southern California waters for legal size bugs. We continue our excellent relationship with the Great Escape and hope to have a great trip especially with our limited load scenario. The bugs were "biting" on our October 2000 dive.

As most of you experienced divers know, Santa Barbara diving provides the very best in underwater topography, marine life, and generally high visibility. Sea lions abound and are always ready to "play". Black sea bass have been sighted on numerous occasions as have relatively large rays sometimes in "flying formations". The reefs are ideal for photography, video, or just looking. Typically, we will circumnavigate this relatively small island to pick off four or five choice spots, including one or two in the environs of Sutil Island.

For the game takers there are a variety of fish, scallops, and lobster as mentioned above. Diving conditions in February are usually pleasant and typically the ocean is cooperative. This dive is suitable for all skill levels. Relative beginners should check with the diversaster to ascertain the specifics of each dive. Great Escape is one of the largest dive boats in the L.A. area and provides an extremely comfortable diving platform. The "verandah" (a.k.a. sun deck) also provides for sun and relaxation on the ride home. 

# **BAHAMAS DIVE TRIP REPORT**

I took a dive trip to dive Blue Holes in the Bahamas from 10/13 to 10/20 on a live aboard called the *Ocean Explorer* - www.oceanexplorerinc.com.

Those of you who know me realize that I don't often take the time to report on a dive trip but this was a great trip and a good charter operation so I thought I would write up a short report. This is a 55' boat that is laid out more efficiently than any other dive boat I have been on. They only take 8 passengers normally - 4 in two staterooms (small) and four in a central bunk-room up forward. There are two heads with showers in the forward bunk-room and two hot showers on deck. Food was great. They do specialty trips in the Bahamas and even snorkeling only trips. If you are thinking of a vacation in the Bahamas, I recommend you look into their schedule.

Blue Holes are so named for the deep blue color of the water at the mouth of the hole as compared to the surrounding water / land. They are the entrance to a cave system and as such are basically the same as a sinkhole in Florida or a cenote in Mexico. We dove a rift line that extends for at least 60 miles along the East Side of Andros Island. All but one of the holes we dove were located offshore on the fringing reef but we did go inland, by truck, one day to dive one in the jungle. Most of these holes are basically a spot where the top of the cave has collapsed and that opening now provides an entrance and access to an upstream and a downstream tunnel.

The unique aspect of this 'cave' diving as compared to other places I have dove is the tidal flow. Because you don't want to be trying to get out of the cave when the tide is flowing in, it is important to time your dive so that you enter at the high tide slack and exit with the outgoing tide. The depth of these dive also dictates that most of this diving is decompression diving. When you combine this with the outgoing tide flow in some fairly narrow openings it makes for some interesting decompression stops. A bit like being in the mouth of a large hose. Then you have to take account of the required surface intervals because of the repetitive deep dives so you end up diving every 12 hours on the high tide slack.

The high tide slack was at 1100 hours on our first day of diving so the second dive of the day was at 2300 hours. With the normal tide shift of about an hour each day, we ended up diving at 3 and 4 AM by the end of the week. This makes for a very interesting meal and sleep schedule. The entire crew was great about accommodating our dive schedule.

The caves were great and many were decorated with stalactites and stalagmites. The inland cave was an awesome rift with beautiful flow stone formations on the walls. It was interesting as we had a GIANT stride entry with a 30' drop (with double 100's) - we lowered the stage bottles down on a block and tackle and put them on in the water. Everything went up on the block and tackle because the cliff was too steep and slippery to climb with the weight of the doubles.

I reached a personal goal of diving to 300' depth in one of the caves and tried to better that a few days later but the cave bottomed out at 281'. We dove tri-mix on dives below 200'.

The surprising highlight of the night dives turned out to be the decompression at the 20' stop. The outgoing tide brings a lot of concentrated nutrients out of the cave and they draw in schools of small fish to feed. The small fish in turn draw in the larger fish etc. etc. The hour plus decompressions were like being in a giant aquarium with the full spectrum of tropical fish parading by in all sizes.

Even I find reliving the details of each dive boring so I won't make you suffer through them.



# DESTRUCTIVE SEAWEED THREATENS CALIFORNIA

An alien green algae (*Caulerpa taxifolia*) has been discovered in a coastal lagoon located approximately 20 miles north of San Diego, California. An aggressive clone of this species has been highly invasive in the Mediterranean Sea, where the government has been unable to control its spread. *Caulerpa taxifolia*, is a species of algae which has never before been documented on the west coast of the Americas.



Although the marine (saltwater) seaweed *Caulerpa taxifolia*, also known a "killer algae", poses no threat to human health, it will have devastating ecological and economic consequences for California if it is allowed to become permanently established. This non-native seaweed threatens California's coastal marine life, including kelp forests, and their related fish, sea mammals, and sea birds.

Caulerpa taxifolia has the ability to form a dense smothering blanket of growth on any surface (rock, sand, or mud). It is capable of extremely rapid growth – up to one inch per day. Any small fragment of this seaweed has the potential to start a new colony, which can expand to cover more than 75 square feet

within one year. It can grow in shallow coastal lagoons as well as in deeper ocean waters, and has reportedly survived up to ten days out of water. Because of these characteristics, an infestation of *Caulerpa taxifolia* can quickly become uncontrollable.

Dispersal of Caulerpa taxifolia throughout the Mediterranean is believed to attributable to fishing gear, boat anchors, and anchor lines.

Learn to recognize the seaweed. New members paying full annual membership allowed one single day dive at approximately two-thirds of member price. Dive 01-C13 does not include air, food, and beverages. #### Great Escape - 22nd Street Landing

South on Harbor freeway, left on Gaffey, left on 22nd Street, down the hill and park in designated areas.

#### Peace - Ventura Marina

North on Ventura freeway to Victoria Ave. in Ventura. Turn left onto Victoria and continue to Olivas Park Drive. Turn right and continue all the way down toward the beach and across Harbor Drive, go to the left onto Spinnaker Drive. Look for Milano's Italian Restaurant and turn right into ne parking area. If you get to the end of Spinnaker, turn around and take the second left. Park adjacent to the berth (Slip #20) to unload, then park overnight in the last row adjacent to Spinnaker Drive.

#### DIVE BOAT POLICY

A club member may, but is not required to, have a boat deposit on file with the club. A club member may make a reservation on an upcoming dive as follows:

A) Unconfirmed reservations may be made for any boat dive at any time. To confirm a reservation, payment in full must be received.

B) For single day dives, divers holding an unconfirmed reservation will be called 3 weeks prior to the dive and advised that payment in full is required no later than 15 days prior to the dive to be confirmed. Dive boat deposits will be considered as payment in full.

C) For two day dives, divers holding unconfirmed reservations will be called 5 weeks prior to the dive and advised that payment in full is required no later than 30 days prior to the dive to be confirmed. Dive boat deposits may be used as part of the payment in full.

D) If payment in full is not received by the deadline, the diver may be replaced by a wait listed diver who has paid in full.

Any reservation may be cancelled two weeks prior to a dive with a full refund. Cancellations will not be accepted within two weeks prior to the dive unless a diver holding a reservation can sell or transfer their reservation to another qualified diver. The dive reservationist will assist in this process, but is not responsible for providing paying alternates. When confirmation is received by the dive boat reservationist that a cancelling diver is being replaced by another qualified diver, the replacement diver is then fully responsible for the cost of the dive.

If a diver has a deposit on file with the club and uses that deposit to secure a reservation on a boat dive, he may not use that deposit to secure additional dives until he has paid the club for the first dive. Two years after a diver has ceased to be a member of the club, his unclaimed dive boat deposit will be forfeited to the club. Only club members of The Sea Divers and members of other selected clubs may make boat dive reservations prior to one month before a scheduled boat dive. Partial refunds from single day boats which do not make the advertised dive location will be passed on to members who request them within two weeks of the
