

We have dived Osborne Bank only once before in 2000. Osborne is a deep advanced dive, with the basic plateau at approximately 130 feet. Surrounding the plateau are depths that go way beyond normal sport diving limits, so extreme care in depth control is required. Nitrogen narcosis is likely to occur, to some degree, on this dive. The plateau itself is essentially flat and provides an environment somewhat different than the more typical reefs in the area. We strongly recommend no spear fishing unless you are extremely comfortable at these depths, distractions can be dangerous. This IS an advanced dive.

Following the Osborne Bank dive we will move to Santa Barbara Island for the rest of our diving. As most of you experienced divers know, Santa Barbara diving provides the very best in underwater topography, marine life, and generally high visibility. Sea lions abound and are always ready to 'play". Black sea bass have been sighted on numerous occasions as have relatively large rays, sometimes in "flying formations". The reefs are ideal for photography, video, or just looking. We will circumnavigate this relatively small island to pick off three or four choice spots, including one or two in the environs of Sutil Island.

For the game takes there are a variety of fish and scallops. Diving conditions in June are usually pleasant and typically the ocean is cooperative. *Great Escape* is one of the largest dive boats in the L.A. area and provides an extremely comfortable diving platform. The "verandah" (a.k.a. sun deck) also provides for sun and relaxation on the way home. Our second two-day dive of 2001 is a great southern outer island cruise and dive to the very best spots. This Friday/Saturday affair has been the making of really outstanding trips in past years.

Begg Rock is a group of pinnacles which rise about 15 feet above the water and then plunge in the most spectacular fashion to over 100 feet with rolling ledges from 30 feet to 60 feet. The rock is located about 7 miles north of San Nicolas Island, and is noted for its huge plate-sized scallops on the deeper ledges (easy to limit out at the one-day limit of 10). Photophiles and video buffs will be well served. Relative beginners should note that Begg Rock is fully exposed to the ocean, but on good days may be dived by all skill levels after appropriate predive consultation with the divemaster and a properly planned dive, with your buddy.

San Nicolas, the outer most of the southern four islands, is noted for its relative remoteness and typically large size fish. Ocean temperatures should be up around 60°F, making diving pleasant. Large fish, such as Calico Bass, Sheephead, etc., can be found in the kelp beds and reefs. We will overnight at San Nicolas, probably in Dutch Harbor, with full dinner, socialize with good friends, and enjoy a typically great evening just relaxing. The following day we will either head to Begg Rock for our second attempt, or cruise to Santa Barbara Island, which is the smallest prettiest island and has a little of everything. The spectacular underwater arches, walls, reefs, sea lions, and other sea life are great for photography and video and visibility is usually exceptional. Again large fish surround the area, including the occasional black sea bass (these are for viewing only!!!).

A SLIGHT CHANGE OF PLAN

The June Oil Rig dive had perfect ocean conditions, flat calm, no swells/surge and 60 plus feet of visibility. Mr. Sun was not fully out but it was a relatively bright day, providing reasonably good light up to 100 feet.


Our first two dives were on Oil Rig *Eureaka*. After several years of diver access the outer structure does not have near the same abundance of scallops as before but inside and towards the south they are as abundant as ever. The growth is still amazing and with no surge or current, exploration was easy. Thermoclines were at 60 feet and 100 feet with temperatures going from about 60°F at the surface to the low 50's °F at depth. Fish (no spearfishing) were abundant as were a myriad of jellyfish. Drop off of divers, in waves, and eventual pick-up was very crisp and efficient. All in all great diving.

Our plan going in was to dive *Eureaka* and then move to the double rig *Elly/Ellen*. Not to be! Due to maintenance work the double rig was off diving limits for the day. We discussed a fall back to either Palos Verdes or the *Olympic* wreck. *Olympic* won hands down, as most on board preferred deeper rather than shallower, also last years attempt at Palos Verdes provided soup diving!! We kept the gate open for an hour and a half to allow for surface interval and/or two possible dives. Conditions were excellent except for a growing surface current as time progressed. The *Olympic* is nearly always a great dive when conditions permit.

Needless to say we had a relatively short run back to 22^{nd} Street, allowing for Saturday evening gear cleaning rather than Sunday AM! Nice day out with three outstanding and for most, relatively deep diving. Scallops galore!! *Great Escape* did an outstanding job all around.

To Individuals Interested in the Marine Life Protection Act:

The Marine Life Protection Act (MLPA: Assembly Bill 993 authored by Assemblyman Shelly) became effective January 1, 2000. This language is now included in the Fish and Game Code (Sections 2850 to 2863). The purpose of the act is to improve the array of Marine Protected Areas (MPAs) in California waters through a comprehensive Master Plan that the Department of Fish and Game (Department) is required to develop. This Master Plan will recommend alternative MPA networks within state waters (from shore out to three miles) to the Fish and Game Commission (Commission).

The MLPA requires the Department to present the draft Master Plan to the Commission by January 1, 2002. A Master Plan Team (Team), consisting of Department and other agency representatives and eight scientists, is assisting the Department in developing the Master Plan (please see Team list on next page). This letter is to inform you of the Team's approach to develop the Master Plan and to invite your initial comments.

Goals and Approach

The basic goals of the MLPA are: 1) to help sustain, conserve and protect marine populations and ecosystems for their economic and intrinsic value; 2) to help rebuild depleted marine populations; 3) to improve recreational, educational, and study opportunities; and 4) to ensure that California's MPAs have clearly defined objectives, effective management measures, adequate enforcement, and are based on sound scientific principles.

The Master Plan recommendation will include existing and newly proposed MPAs. Each MPA will be re-named or named using a new classification system established by the Marine Managed Areas Improvement Act (Assembly Bill 2800[Shelly]). These new classifications are:

State Marine Reserve: Injuring, damaging, taking or possessing any living, geological or cultural marine resource ("take") is prohibited. Some scientific collecting by permit may be allowed.

State Marine Park: Commercial take is prohibited. Recreational take and scientific collecting by permit will be allowed, although some forms of recreational take may be restricted.

State Marine Conservation Area: Certain commercial and recreational take and scientific collecting by permit may be allowed.

The Team has divided California marine waters into four regions based on assemblages of similar marine animals, plants and habitats:

North marine region: California-Oregon border to Pt. Arena.

North-Central marine region: Pt. Arena to Pt. Año Nuevo, including the Farallon Islands. South-Central marine region: Pt. Año Nuevo to Pt. Conception, including San Miguel, Santa Rosa, and San Nicolas Islands.

South marine region: Pt. Conception to California-Mexico border, including Santa Cruz, Anacapa, Santa Barbara, Santa Catalina, and San Clemente Islands.

The Team has identified eight habitat types to be represented in MPA networks. These consist of hard and soft seafloor in four depth ranges: intertidal, 0-30 meters (0-100 ft.), 30-200

meters (100-660 ft.), and greater than 200 meters. Networks will also include, where feasible, spawning and nursery areas and the following specialized habitats: rocky reefs, underwater pinnacles, kelp forests, submarine canyons, and seagrass beds.

As an initial step, California's existing MPAs are being evaluated for incorporation into the Master Plan. In order to achieve the MLPA goals, the Team may recommend additional MPAs and modification of boundaries and the degree of protection in existing MPAs. The MLPA requires that similar types of habitats and communities be replicated, to the extent possible, in more than one State Marine Reserve in each region. In recommending specific sites, the Team will also consider species most likely to benefit from protection.

Your Comments

The Master Plan must also take into account the social and economic impacts of any new or existing MPAs. We recognize that developing an MPA network with improved resource protection will have short-term impacts on users. Our aim is to minimize any short-term losses while maximizing long-term benefits. We need your feedback to accomplish this goal. The Team is seeking your specific comments about the effectiveness of existing MPAs, recommendations for modifying existing MPAs, and recommendations for additional MPAs. Your interest, comments, and participation are important to meet the requirements of the MLPA and to create a system that benefits all of California. More Information

We will provide more information and seek further comment during two series of public meetings and workshops. These are tentatively scheduled for July and September 2001 and will be held throughout the State. The draft master plan is required to be completed by January 2002. Once completed, the draft plan will be available for public review and comment. Formal public comment will also be available during Commission hearings concerning the implementation of the Master Plan. These will most likely occur in the Spring of 2002.



North on Ventura freeway to Victoria Ave. in Ventura. Turn left onto Victoria and continue to Olivas Park Drive. Turn right and continue all the way down toward the beach and across Harbor Drive, go to the left onto Spinnaker Drive. Look for Milano's Italian Restaurant and turn right into the parking area. If you get to the end of Spinnaker, turn around and take the second left. Park adjacent to the berth (Slip #20) to unload, then park overnight in the last row adjacent to Spinnaker Drive.

DIVE BOAT POLICY

A club member may, but is not required to, have a boat deposit on file with the club. A club member may make a reservation on an upcoming dive as follows:

- A) Unconfirmed reservations may be made for any boat dive at any time. To confirm a reservation, payment in full must be received.
- B) For single day dives, divers holding an unconfirmed reservation will be called 3 weeks prior to the dive and advised that payment in full is required no later than 15 days prior to the dive to be confirmed. Dive boat deposits will be considered as payment in full.
- C) For two day dives, divers holding unconfirmed reservations will be called 5 weeks prior to the dive and advised that payment in full is required no later than 30 days prior to the dive to be confirmed. Dive boat deposits may be used as part of the payment in full.
- D) If payment in full is not received by the deadline, the diver may be replaced by a wait listed diver who has paid in full.

Any reservation may be cancelled two weeks prior to a dive with a full refund. Cancellations will not be accepted within two weeks prior to the dive unless a diver holding a reservation can sell or transfer their reservation to another qualified diver. The dive reservationist will assist in this process, but is not responsible for providing paying alternates. When confirmation is received by the dive boat reservationist that a cancelling diver is being replaced by another qualified diver, the replacement diver is then fully responsible for the cost of the dive.

If a diver has a deposit on file with the club and uses that deposit to secure a reservation on a boat dive, he may not use that deposit to secure additional dives until he has paid the club for the first dive. Two years after a diver has ceased to be a member of the club, his unclaimed dive boat deposit will be forfeited to the club. Only club members of The Sea Divers and members of other selected clubs may make boat dive reservations prior to one month before a scheduled boat dive. Partial refunds from single day boats which do not make the advertised dive location will be passed on to members who request them within two weeks of the dive.


