Our August General Meeting promises a look at an unusual aspect in diving – the perspective of the LAPD on their Underwater Dive Unit. The Los Angeles Police Department Underwater Dive Unit manages all underwater criminal investigations/operations for the City of Los Angeles to include deep water operations, high altitude diving, limited/zero visibility diving, night diving, contaminated water diving, evidence preservation, underwater photography, underwater navigation, vessel hull search procedures (bomb and narcotics), body recovery, lift-bag operations, and all related search and recovery techniques. The aforementioned aspects of the LAPD UDU will be addressed during the presentation.

The UDU will be represented by Officer Doug Datria and Officer Lee McMillion. Mr. Datria has 13 years with the LAPD and is currently assigned to Harbor Division Special Problems. He has been with the Underwater Dive Unit for 8 years and is a team leader. Mr. McMillion has 13 years with the LAPD and is currently assigned to Metropolitan Division SWAT. He has been with the Underwater Dive Unit for 3 years and is a team leader.

This dive is a new combination for the Club. Instead of diving the *Palawan*, *Avalon*, and *Dominator* wrecks, as previously listed, we are combining the *U.S.S. Moody* wreck with the very popular oil rig dive *Eureka*. We will leave 22nd Street at 7:00 AM prompt and head out to the *Moody* wreck site which is for very experienced divers only.

The *Moody* was decommissioned at San Diego 2 June 1930 and was towed to Mare Island Navy Yard arriving on the 8th. The destroyer was struck from the Navy list 3 November and scrapped in accordance with the London Treaty limiting naval armaments.

She was headed for the breaking yard when MGM purchased her for the 1933 movie "Hell Below" which starred Robert Montgomery and Jimmy Durante. She was towed into Craig shipyard and reworked to represent a German destroyer for the movie. To simulate her sinking by "torpedoes" by the American submarine, AL-14, Merritt-Chapman & Scott Corporation; Sea Salvors Since 1860, were hired for the sinking. Placing a charge of dynamite just aft of the bridge, the *Moody* was blown in two around noon on February 21, 1933, and finally sank at 5:30 that evening. The following day, with bubbles and oil still coming to the surface, the wreck was wire dragged and found that the minimum depth exceeded 90 feet.

Rediscovered by local wreck divers in 1973, the *Moody*, resting in 140 fsw, is strictly a dive for the very experienced. The wreck is broken into two sections. Given the depth, the *Moody* has remained protected from any surf however, the once intact hull sections have collapsed downward. The bow, twisted and lying on its side, has formed a bowl in the sand at 150 feet. The stern lays upright, complete with propellers intact. The two sections lay over 100 feet apart – too far apart to swim at 140 feet. It is likely we will make two dives on the wreck conditions permitting.

Lying several miles from the shore, the waters are unprotected and strong currents can arise. Visibility at this remote site is usually good, averaging over 20 feet. However, the tall water column above absorbs most of the light, requiring the use of a dive light. On rare occasions, visibility may exceed 40 feet and there are even stories about divers being able to see both sections at once – over 100 feet of visibility!

The four stack destroyers were virtually made of brass – it's main attraction for wreck divers. Others found it to be one of the few areas in Southern California with a dense population of tall, white stalks of *Metridium* anemones.

We will then leave the *Moody* and head out to *Eureka*, the furthest and deepest of the oil rigs. Once in place (live boat!) the first of several groups of divers will enter the water to explore the below surface rig structure and the attendant sea life. In particular scallops will be of significant interest to game takers. Spearfishing is strictly prohibited at the oil rigs. Video and photography opportunities should be excellent and quite different from normal reef diving. It is imperative that all divers watch their depth and bottom times as this rig is in extremely deep water and although the legs are a good reference in what would otherwise be a blue water situation, it's easy to lose track. As divers surface, they should group up with other surfaced divers, such that the boat can pick up a group at a time, not individual divers. Please watch the divemaster's signals to maintain an efficient pick-up process.

Once more note that the *Moody* is a seriously advanced dive but *Eureka* can be dived shallow. As is typical of all Sea Diver charters, the trip includes air, food, snacks, and beverages and has a limited load of 28 divers. Over the past few years we have been very successful at Richardson's Rock, Boomerang, Skyscraper, Wilson Rock, Castle Rock, Egg Rock and Little Wilson. Weather permitting several of the pinnacles will feature on this charter. We made five on our May '01 charter.

Other great spots will include a selection on San Miguel from Bennett Point, Judith Rock, Tyler Bight, Wychoff Ledge, Simonton Cove and Harris Point. Potential spots at Santa Rosa will include South Point, Ford Point, Bechers Bay area and Talcott Shoal. As always we can tailor the choices based on weather and diver desires.

All of the areas should provide great opportunities for scallops and a variety of fish for the game takers and the very best for photography and/or video.

The food fare on the *Peace* is always outstanding and plentiful. The first day will provide heavy duty diving, for those so inclined, with up to 6 dives possible with a night dive for those still interested. The second day will be more leisurely with 3 or 4 dives anticipated. Dive spots will include areas suitable for intermediate divers and hopefully some of the more advanced spots covering the full range of diver desires and capabilities.

DIVE THE YUKON

JOINT VENTURE WITH THE WRECK DIVERS

When: 29 September 2001- Departure 11:30 AM (Return 5:30 PM)

Boat: Lois Ann – West Mission Bay, San Diego Sea Diver Member Price: \$55 (includes food* and air)

The Yukon is California's latest and most popular wreck, both in and outside of diving circles. It is different from nearly all other wrecks as it is completely intact, which also makes it one of California's most dangerous wrecks to dive.

Untike most ships with large open holds for cargo, the *Yukon* was designed to carry a crew—its bulkheads and low decks form a maze of narrow passages and small compartments, some of which are over 50' from the nearest exit. To compound the potential danger, the ineffectual sinking of the *Yukon* left it on its portside, allowing sand and silt to fill the hull and block off several exits. The orientation of the ship is now offset by a strong list, increasing the depth from what was originally planned and the depths listed on the maps of the wreck.

Divers should be advised that entering the *Yukon* is no different than penetrating other wrecks or caves. Diving below an overhead environment is a **technical dive** and should only be attempted by those properly trained (use of thirds) and equipped (gear that includes a reel, redundant lighting and air sources).

The Yukon nearly experienced its first fatality on the day it was opened to the public when an instructor nearly lost his life. After 30 minutes of being trapped inside, he finally found his way out of the wreck and onto the sand. At 100 feet deep and 100 psi left in his tank, he dropped his weight belt and shot for the surface, negating his 10 minute decompression stop.

As a corporate sponsor of Project *Yukon*, the California Wreck Divers encourages and supports the use of shipwrecks for artificial reefs. However, we condone diver safety above all. When diving the *Yukon* or other wrecks, please exercise good judgement and caution.

Two die in fish dismemberment

PORT MORESBY Friday 6 July 2001

Two Papua New Guinea fishermen have bled to death after having their penises bitten off by pirahna-like river fish.

The fish, which zero in on urine streams in the water, have struck terror among villagers along the Sepik River, in north-western PNG.

Authorities believe the killer fish is an introduced member of the South American pacu family and a relative of the piranha.

In both of last month's fatalities, the fish demonstrated a trait of the piranha by following a trail of urine in the water, swimming to its source and then biting it off with razor-sharp teeth. Some believe the killer may be a food-source fish introduced from Brazil in 1994 by the United Nations Food and Agricultural Organization and the PNG National Fisheries Authority.

However, marine biologist and aquaculturist Ian Middleton said he believed they were a different species introduced from across the PNG-Indonesia border.

He believed the fish had started biting humans because of a lack of naturally occurring food. "The reason for biting people on their genitals is a result of the fish detecting a chemical change in the water, swimming up the urine trail and biting the genitals."

This behavior was well documented in the Amazon, he said.

The director of the PNG Office of Environment and Conservation, Dr Wari Iamo, yesterday expressed "grave concern and dissatisfaction" at the way some government agencies and donor organisations had gone about importing exotic plant and animal species.

SUMMER HAS COME

Osborne Bank was out before we began our late June trip due to diversater issues. Never the less, with a near full boat we headed to Santa Barbara Island and other reefs to dive.

After a planned rendezvous with the *Horizon* to hand over full tanks as their main compressor had died on day one of a three day trip, we anchored at Hidden Reef. Conditions were fairly good with 4 to 5 foot swells, no current at the surface, 50 plus feet of visibility and mid 60's °F temperature. The reef plateau is at about 60 feet with a very nice wall dropping off to about 120 feet. Not quite Osborne but a real nice dive. Towards the end of the dive a noticable current was coming up, especially at depth. *Horizon* which was about a half mile away got several of their divers caught up in the increasing current and spend on hour picking up errant divers.

The second spot – following the "Hidden" method – we anchored on a not well known wall on the outside of Sutil. Now known as Delaney's Secret Reef (a.k.a. Kalohi's Secret Reef), it also contained a wall to 120 feet. Initially the anchor was dropped over the edge and down the wall. After several divers had entered the water the boat swung nearly 180°, thus pulling the anchor away from the wall. With almost no scope to the 120+ feet sandy bottom, the boat started to drag anchor. Long story short, half the boat never made the dive and the other half most didn't see the wall, just sand at 120 feet or so!!

Moving right along the next spot was east of Sutil and the south side of Santa Barbara. Not a great spot! Topography was fine but the outcrops of rock, between oceans of sand, were not resplendent in sea life. Visibility was down at 25-30 feet, temperature in the mid 60's °F and no current. For the final spot we anchored just east of Shag Rock on the north side of Santa Barbara. A possible halibut area did not produce as hoped. Conditions were much the same as dive three. By now the sun was fully out and hot was setting in. The run back was calm and just a perfect summer day. We reached the dock about 5:30 PM.

We did award one, sort of, booby to Mark H. for bringing fish back to the boat without a stringer, instead utilizing his camera gear!.

ANOTHER BLACK SEA BASS SPEARED!!

To all who may be concerned,

Just three weeks after a disturbing e-mail was sent to me depicting a giant sea bass swimming around Catalina Island with a spear in it's side, another similar unlawful and cruel act of this nature was discovered at Anacapa Island. This animal shown in the still clip extracted from a video was observed on two survey dives at Anacapa on July 6-2001. The fish was hit with a large shaft with a breakaway tip that is embedded on the left side behind the head. The video tape graphically shows how the shaft and tip continue to injure the animal. As the fish swims, the shaft which also has a length of cable attached to it, re-enters the wound as the end of the shaft bumps against the reef. In addition, when the cable drags the bottom it tugs on the spear tip that is lodged in the body of this fish. his is a large mature animal that did have the potential to contribute to the seasonal spawning aggregation, now it suffers a potentially mortal wound, It is disturbing to know of two such incidents, coupled with the fact that they occurred at two locations and over such a short time period. These actions are intolerable, and anything that can be done by anyone to discourage this unconscionable behavior would be helpful.



New members paying full annual membership allowed one single day dive at approximately two-thirds of member price. Dive 01-C13 does not include air, food, and beverages. All dives except 01-C13 are limited load of 28 divers.

Great Escape - 22nd Street Landing

South on Harbor freeway, left on Gaffey, left on 22nd Street, down the hill and park in designated areas.

North on Ventura freeway to Victoria Ave. in Ventura. Turn left onto Victoria and continue to Olivas Park Drive. Turn right and continue all the way down toward the beach and across Harbor Drive, go to the left onto Spinnaker Drive. Look for Milano's Italian Restaurant and turn right into the parking area. If you get to the end of Spinnaker, turn around and take the second left. Park adjacent to the berth (Slip #20) to unload, then park overnight in the last row adjacent to Spinnaker Drive.

DIVE BOAT POLICY

A club member may, but is not required to, have a boat deposit on file with the club. A club member may make a reservation on an upcoming dive as follows:

- Unconfirmed reservations may be made for any boat dive at any time. To confirm a reservation, payment in full must be received.
- For single day dives, divers holding an unconfirmed reservation will be called 3 weeks prior to the dive and advised that payment in full is required no later than 15 days prior to the dive to be confirmed. Dive boat deposits will be considered as payment in full.
- For two day dives, divers holding unconfirmed reservations will be called 5 weeks prior to the dive and advised that payment in full is required no later than 30 days prior to the dive to be confirmed. Dive boat deposits may be used as part of the payment in full.
- If payment in full is not received by the deadline, the diver may be replaced by a wait listed diver who has paid in full.

Any reservation may be cancelled two weeks prior to a dive with a full refund. Cancellations will not be accepted within two weeks prior to the dive unless a diver holding a reservation can sell or transfer their reservation to another qualified diver. The dive reservationist will assist in this process, but is not responsible for providing paying alternates. When confirmation is received by the dive boat reservationist that a cancelling diver is being replaced by another qualified diver, the replacement diver is then fully responsible for the cost of the dive.

If a diver has a deposit on file with the club and uses that deposit to secure a reservation on a boat dive, he may not use that deposit to secure additional dives until he has paid the club for the first dive. Two years after a diver has ceased to be a member of the club, his unclaimed dive boat deposit will be forfeited to the club. Only club members of The Sea Divers and members of other selected clubs may make boat dive reservations prior to one month before a scheduled boat dive. Partial refunds from single day boats which do not make the advertised dive location will be passed on to members who request them within two weeks of the dive.
