AUGUST GENERAL MEETING: MIKE BRENNAN – SHOOTING BIG ANIMALS (with a camera)

Our August General Meeting will feature Mike Brennan discussing how to shoot big animals underwater...with a camera.

Mike was certified with NAUI in 1995 and got a Nitrox Cert with IANTD in the fall of 2000 followed by a GUE cert in Spring of 2001. He has around 300 logged dives and many that aren't (he only started logging dives in 1999). He's been carrying a camera underwater since 1998 and mainly uses Titanium Nikon F3s housed in Ikelite Housings with Ikelite strobes.

Mike's program will cover some tips on photographing big animals such as Mantas, Turtles, Sharks and others. He'll talk only briefly about equipment since there is so much stuff on the market and different setups work for different people. He wll be bringing some of his equipment and demonstrating among other things, how to use a hand held strobe and irritating little things like the regulator banging on the housing and scaring the subject away. He will discuss in more detail, the nuances of approaching various animals, including controlling breathing, getting away from the crowd of divers and what he does when he sees a large animal worth photographing. Our next General Meeting is on Tuesday 6 August at Round Table Pizza in Hawthorne starting at 7:00 PM.

We will leave 22nd Street at 7:00 AM prompt and head out to the *Moody* wreck site which is for very experienced divers only.

The *Moody* was decommissioned at San Diego 2 June 1930 and was towed to Mare Island Navy Yard arriving on the 8th. The destroyer was struck from the Navy list 3 November and scrapped in accordance with the London Treaty limiting naval armaments.

She was headed for the breaking yard when MGM purchased her for the 1933 movie "Hell Below" which starred Robert Montgomery and Jimmy Durante. She was towed into Craig shipyard and reworked to represent a German destroyer for the movie. To simulate her sinking by "torpedoes" by the American submarine, AL-14, Merritt-Chapman & Scott Corporation; Sea Salvors Since 1860, were hired for the sinking. Placing a charge of dynamite just aft of the bridge, the *Moody* was blown in two around noon on February 21, 1933, and finally sank at 5:30 that evening. The following day, with bubbles and oil still coming to the surface, the wreck was wire dragged and found that the minimum depth exceeded 90 feet.

Rediscovered by local wreck divers in 1973, the *Moody*, resting at 140 feet, is strictly a dive for the very experienced. The wreck is broken into two sections. Given the depth, the *Moody* has remained protected from any surf however, the once intact hull sections have collapsed downward. The bow, twisted and lying on its side, has formed a bowl in the sand at 150 feet. The stern lays upright, complete with propellers intact. The two sections lay over 100 feet apart – too far apart to swim at 140 feet. It is likely we will make two dives on the wreck conditions permitting.

Lying several miles from the shore, the waters are unprotected and strong currents can arise. Visibility at this remote site is usually good, averaging over 20 feet. However, the tall water column above absorbs most of the light, requiring the use of a dive light. On rare occasions, visibility may exceed 40 feet and there are even stories about divers being able to see both sections at once – over 100 feet of visibility!

The four stack destroyers were virtually made of brass – it's main attraction for wreck divers. Others found it to be one of the few areas in Southern California with a dense population of tall, white stalks of *Metridium* anemones.

We will then leave the *Moody* and head to *Eureka*, the furthest and deepest of the oil rigs. Once in place (live boat!) the first of several groups of divers will enter the water to explore the below surface rig structure and the attendant sea life. Video and photography opportunities should be excellent and quite different from normal reef diving. It is imperative that all divers watch their depth and bottom times as this rig is in extremely deep water and although the legs are a good reference in what would otherwise be a blue water situation, it's easy to lose track. As divers surface, they should group up with other surfaced divers, such that the boat can pick up a group at a time, not individual divers. Please watch the divemaster's signals to maintain an efficient pick-up process.

Once more note that the *Moody* is a seriously advanced dive but *Eureka* can be dived shallow. As is typical of all Sea Diver charters, the trip includes air, food, snacks, and beverages and has a limited load of 28 divers. All of the areas should provide great opportunities for scallops and a variety of fish for the game takers and the very best for photography and/or video.

The second day will be more leisurely with 3 or 4 dives anticipated. Dive spots will include areas suitable for intermediate divers and hopefully some of the more advanced spots covering the full range of diver desires and capabilities.

SECOND DAY A CHARM!

The *Great Escape* made a 90° turn, about 4:00 AM Friday morning, indicating that the rough seas had nixed a first day shot at Begg Rock. As a result we were forced to dive the South Side of San Nicolas Island for the first day. Diving was fair to good with five dives available for those so inclined. Some of us were not!! Dive depths ranged from 60 feet maximum to 40 feet maximum, temperature varied between 60°F and 55°F, no current, calm (tucked in!) with a little surge at a couple of spots. Visibility ranged from 25 to 40 feet. Little game was taken but it was noticed that small Red Abalone were seen in areas where Red Abs were once plentiful. Good! After dive number two we made a run to the West End to see if Begg was yet viable. Not so, unless we dived a live boat in uncomfortable conditions, not worth the risk, even for Begg.

We overnighted just off the West End. About 4:15 AM, engines up and running, we headed North towards Begg Rock. The ocean was surprisingly calm and we made Begg with relative ease. Anchoring was a little difficult due to inconsistent light winds. Eventually Tim B. dropped the anchor in 80-90 feet of water. Chris G. scouted the anchor and after dropping it over the edge of a wall, released the signal plate that all was well. Tim B. had missed a 55 feet deep pinnacle by about 30 feet right. On descending the anchor line the pinnacle became visible almost immediately. Depths beyond were over 130 feet. The Rock was spectacular as ever, albeit with less large scallops, with visibility at least 60 feet, no current, no surge but only slightly over 50°F temperature. We stayed for two memorable dives and initiated several Begg Rock Virgins!!

We reluctantly left about 9:20 AM for the eight hour run back to Long Beach. One Blue Whale was sighted on the way back. We awarded one booby to Sharon H. for attempting to dive Begg with no weight belt. Did not work! We also presented a "Hero Award" to Tammy L. for diving in an ill fitting borrowed wet suit, at Begg, after the neck seal on her dry suit tore. She looked nearly frozen after the dive!! *Great Escape* did a great job, with Tim B. and his crew being very supportive. The food was excellent and varied. We especially appreciated the run for Begg on the second day – way to go!!

Dear Marine Recreational Fishery Participants and Interested and Affected Parties:

Following federal action taken last week by the Pacific Fishery Management Council (Council), effective July 1, California's recreational fishery for shelf rockfish and lingcod will be closed in ocean waters 20 fathoms (120 feet) and deeper south of Cape Mendocino (Humboldt County).

The closure prohibits the take of rockfish, lingcod, ocean whitefish, and California scorpionfish (sculpin) in waters 20 fathoms and greater in depth. In waters less than 20 fathoms, recreational anglers may continue to take "nearshore" species of rockfish and lingcod, and retain two "shelf rockfish (not including bocaccio, cowcod, canary, and yelloweye), if they are taken incidentally while fishing in waters less than 20 fathoms in depth.

Allowing for the continued take of shelf rockfish and lingcod would pose a threat to bocaccio rockfish because shelf rockfish typically occupy the same waters between 20 and approximately 150 fathoms in depth. The Council requested the California Department of Fish and Game (DFG) close these shelf fisheries because of the potential to incidentally catch boccacio while fishing for other species in those areas. The Council took similar action for commercial fishing in federal waters.

The DFG will implement the closure in state waters 20 fathoms or greater in depth to comply with the new federal rules, pursuant to Section 27.82, Title 14, California Code of Regulations. The closure area specifically includes waters south of a line extending due west from a point on the mainland shore (40 degrees, 10 minutes north latitude) near Cape Mendocino.

Bocaccio has been declared "overfished" by the Council and is being managed under stringent rebuilding plans set forth by the Magnuson-Stevens Act. According to federal assessments, bocaccio have declined to about 5 percent of their original abundance. The Council's Groundfish Management Team released new scientific evidence suggesting that these additional rebuilding measures for bocaccio, canary and yelloweye rockfish species need to be stronger for full recovery to be achieved.

This action does not affect fishing for species other than rockfish, lingcod, ocean whitefish, and California scorpionfish. Species that are unaffected by the closure include salmon, striped bass, halibut, albacore, barracuda, white seabass, and others that may be taken in waters greater than 20 fathoms. Dear Marine Recreational Fishery Participants and Interested and Affected Parties:

In May 2002, the Fish and Game Commission (Commission) adopted regulations which provide authority to the Department of Fish and Game (Department) to close either or both recreational or commercial sectors of the sheephead, greenling and cabezon fisheries when their allowable harvest levels are projected to be reached. Upon projected attainment of any sport allocation, the Department shall notify the Commission and the public of an upcoming closure via Department news releases and/or notification letters at least 10 days in advance of the specified date.

This letter is to inform you that effective 12:00 am Monday, July 29, 2002, the sport fishery for cabezon (*Scorpaenichthys marmoratus*) will be closed for 2002 or until further notice, pursuant to Section 52.10, Title 14, California Code of Regulations.

Based on projections from recent recreational catch estimates derived from the Marine Recreational Fisheries Statistics Survey (MRFSS), the sport allocation of 84,330 pounds of cabezon for calendar year 2002 will be taken by the closure date. The prohibition on the landing of these species will be in effect throughout the State of California.

Based on MRFSS information available to date, the Department estimates that approximately 68,000 pounds of cabezon were landed by sport anglers in California between the months of January and June 2002. This is a significant increase from 2001 landings during these same months, totaling approximately 39,000 pounds. As cabezon landings historically increase considerably in the summer months, the Department is estimating that the recreational allocation will be reached in full by the specified closure date:

Should catches fall substantially below the defined allowable harvest levels, the Department may evaluate the potential of re-opening the cabezon fishery for a specified time later in the year. ^{*}Prices are all inclusive (air, food, and beverages). Non-members add \$10 for single day and \$15 for two-day dives. New members paying full annual membership allowed one single day dive at approximately two-thirds of member price. Free Diver price is 75% of full price. Bubblewatchers price is 50% of full price. Dive 02-C14 does not include air, food, and beverages. All dives except 02-C14 and 02-10 are limited load of 28 divers. Dive 02-10 (a.k.a. Bugzilla) is a limited load of 24 divers.

Great Escape - Long Beach Sportfishing, Berth 55

South on 710 freeway, exit at Pico off ramp, thru light, right at first driveway past traffic signal. Park in "Sportfishing Parking" after unloading car.

Peace - Ventura Marina

North on Ventura freeway to Victoria Ave. in Ventura. Turn left onto Victoria and continue to Olivas Park Drive. Turn right and continue all the way down toward the beach and across Harbor Drive, go to the left onto Spinnaker Drive. Look for Milano's Italian Restaurant and turn right into the parking area. If you get to the end of Spinnaker, turn around and take the second left. Park adjacent to the berth (Slip #20) to unload, then park overnight in the last row adjacent to Spinnaker Drive.

DIVE BOAT POLICY

A club member may make a reservation on an upcoming dive as follows:

Unconfirmed reservations may be made for any boat dive at any time. To confirm a reservation, payment in full must be received.

For single day dives, divers holding an unconfirmed reservation will be called 3 weeks prior to the dive and advised that payment in full is required no later than 15 days prior to the dive to be confirmed.

For two day dives, divers holding unconfirmed reservations will be called 4 weeks prior to the dive and advised that payment in full is required no later than 21 days prior to the dive to be confirmed.

If payment in full is not received by the deadline, the diver may be replaced by a wait listed diver who has paid in full.

Pre-assignment of bunks will be made on a first paid basis for selected dives.

Executive Officers and club members who annually support at least one third of Sea Diver charters may pay on the boat but must get prior approval from the Dive Boat Reservationist or the Club President.

Any reservation may be cancelled two weeks prior to a dive with a full refund. Cancellations will not be accepted within two weeks prior to the dive unless a diver holding a reservation can sell or transfer their reservation to another qualified diver. The dive reservationist will assist in this process, but is not responsible for providing paying alternates. When confirmation is received by the dive boat reservationist that a cancelling diver is being replaced by another qualified diver, the replacement diver is then fully responsible for the cost of the dive.

Only club members of The Sea Divers and members of other selected clubs may make boat dive reservations prior to one month before a scheduled boat dive. Partial refunds from single day boats which do not make the advertised dive location will be passed on to members who request them within two weeks of the


